**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks ("Release") is made as of November 30, 2022, by **BANK OF AMERICA, N.A.**, as administrative agent (in such capacity, "Agent"), in favor of **EXCALIBAR MINERALS LLC**, a Texas limited liability company (the "Grantor").

WITNESSETH:

WHEREAS, the Grantor, certain affiliates of the Grantor and Agent entered into that certain Security Agreement dated as of June 30, 2016 (as amended, restated, or otherwise modified from time to time, the "Security Agreement"), pursuant to which Grantor executed that certain Trademark Security Agreement Supplement dated as of June 30, 2016 and recorded on July 1, 2016, at the United States Patent and Trademark Office at Reel 5825, Frame 0449. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, the Grantor granted Agent, under the terms of the Security Agreement, a security interest in favor of Agent, in all right, title and interest in, to and under the (i) Trademarks, including without limitation the Trademarks listed on Schedule A (the "Specified Trademarks") and (ii) Trademark Licenses relating to the Trademarks listed on Schedule A (the "Specified Trademark Licenses").

WHEREAS, Agent has agreed to terminate and release its security interest in the Specified Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt of which is hereby acknowledged, and intending to be legally bound, Agent hereby:

1. irrevocably releases, terminates and discharges, and irrevocably assigns, transfers and conveys to the Grantor, any and all of its security interest in the Specified Trademarks, including the goodwill of the business symbolized thereby, the Specified Trademark Licenses, and all proceeds thereof, including, without limitation, any claims against third parties for infringement thereof; and
2. authorizes and requests that the Commissioner of the United States Patent and Trademark Office and any other applicable government authority record this Release.


