Release of Security Interest in Trademarks

WHEREAS, the Grantor desires Lender to release, discharge, terminate and cancel its continuing security interest in the Trademarks of the Grantor;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Trademarks, including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Trademarks.


The Lender authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.
