PARTIAL RELEASE OF THE TRADEMARK SECURITY AGREEMENT

This PARTIAL RELEASE OF THE TRADEMARK SECURITY AGREEMENT (the "Release") is made as of December 15, 2022, by BANK OF AMERICA, N.A, as Administrative Agent for the Secured Parties (as defined in the Security Agreement referred to below) (in such capacity, the "Administrative Agent").

W I T N E S S E T H

WHEREAS, pursuant to (i) that certain Security Agreement, dated July 30, 2021, by and among the grantor parties thereto and the Administrative Agent (as heretofore amended, supplemented or otherwise modified, the "Security Agreement"), and (ii) that certain Trademark Security Agreement, dated July 30, 2021 by and among the grantors party thereto and the Administrative Agent (the "Trademark Security Agreement"), pursuant to which Global Experience Specialists, Inc., a Nevada corporation (the "Grantor"), granted the Administrative Agent a continuing security interest in all of the Grantor's right, title and interest in, to and under certain collateral;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 30, 2021 at Reel 7371, Frame 0699;

WHEREAS, the Grantor has requested, and the Administrative Agent wishes to provide, a document suitable for recording in the USPTO for purposes of recording the release, relinquishment and discharge of its interest in the trademark collateral of the Grantor identified on Schedule A attached hereto (the "Released Trademark Collateral"); and

WHEREAS, in reliance of the representations and warranties concerning the transactions referenced in that certain Confirmation of Partial Release, dated December 15, 2022, by and among Viad Corp., as Borrower, and the Administrative Agent, the Administrative Agent, on behalf of itself and the Secured Parties, desires to terminate and grant a release of its security interest in the Released Trademark Collateral as provided in this Release.


NOW THEREFORE, for good and valuable consideration previously tendered by the Grantor, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself and the Secured Parties, does hereby agree as follows:

1. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement, as applicable.
2. The Administrative Agent, on behalf of itself and the Secured Parties, without representation, warranty or recourse, hereby (a) releases, relinquishes, terminates and discharges its security interest in and to the Released Trademark Collateral in its entirety and (b) reassigns to the Grantor any and all right, title and interest of any nature whatsoever the Grantor may hold in or to the any of the Released Trademark Collateral and associated common law rights and goodwill appurtenant thereto.
3. This Release is applicable only and solely with respect to the Released Trademark Collateral and to no other collateral arising under the Security Agreement or Trademark Security Agreement. The Administrative Agent retains all security interests, liens, rights, titles and interests pledged and granted to the Administrative Agent under the Security Agreement and Trademark Security Agreement with respect to all such other collateral, and the Administrative Agent's security interest, liens, rights, titles and interests in such other collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Release.
4. The Administrative Agent, on behalf of itself and the Secured Parties, authorizes the United States Patent and Trademark Office and any other applicable governmental authority to record this Release.
