TRADEMARK ASSIGNMENT

This Assignment expressly includes all rights to income and license fees deriving from the Marks to the extent earned after the date hereof, and all causes of action, claims and rights to damages or profits arising by reason of any past, present or future infringements or unauthorized uses of the Marks, and the right to sue for and collect such damages or profits, in each case as permitted by law. The Commissioner for Trademarks is requested to issue any certificates of registration for the Marks to Assignee.

This Agreement constitutes the entire understanding between the Parties and supersedes any and all prior or contemporaneous understandings and agreements, whether oral or written, between the Parties with respect to the subject matter hereof.

This Assignment shall be governed by the laws of the State of Delaware without regard to conflicts of law principles thereunder. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns.

This Agreement may be executed in one or more counterparts, all of which together will constitute one and the same instrument. A signature transmitted by facsimile or other electronic means shall have the same force and effect as an original signature.


