RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this “**Release**”) is made by NATIONAL BANK OF CANADA, a Canadian chartered bank (the “**Secured Party**”), and is effective as of August 26, 2022 (the “**Effective Date**”). All capitalized terms used in this Release but not otherwise defined herein have the meanings specified in the Security Documents (as defined below), whether defined therein or by reference to another agreement.

WHEREAS, GOOD NATURED PRODUCTS INC. and GOOD NATURED PRODUCTS (CAD) INC., each a corporation incorporated under the *Business Corporations Act* (British Columbia) (collectively, the “**Grantors**”), each entered into that certain US Intellectual Property Security Interest Agreement dated as of October 28, 2021 (as amended, restated, supplemented or modified from time to time, the “**Security Documents**”), in favor of the Secured Party, pursuant to which the Grantors granted to the Secured Party a security interest in any and all right, title and interest in such Grantor’s Patents, Trademarks, and Copyrights, including without limitation, the patent, trademark registrations and trademark applications set forth on Schedule “A” attached hereto (the “**Intellectual Property Collateral**”);

WHEREAS, the Security Documents were recorded with the U.S. Patent and Trademark Office (“**USPTO**”) on November 17, 2021 at Reel/Frame 7497/0659 for the Trademarks and Reel/Frame 058143/0108 for the Patents; and

WHEREAS, the Secured Party now desires to terminate and release its security interest in and to the Intellectual Property Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby unconditionally and expressly releases, terminates, and extinguishes as of the Effective Date any and all of its right, title and interest in and to any and all security interests established under and pursuant to the Security Documents it may have upon the Intellectual Property Collateral and hereby assigns, grants and conveys to the Grantors any and all of the Secured Party’s right, title and interest in and to the Intellectual Property Collateral;

AND the Secured Party shall, at the request and cost of each Grantor, take all further actions, and provide to each Grantor, its successors and assigns, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by a Grantor to more fully and effectively release, terminate and extinguish any such security interests upon such Intellectual Property Collateral;

AND the Secured Party authorizes and requests that the Commissioner for Trademarks and Patents of the USPTO and any other applicable government officer record this Release;

AND this Release shall be binding upon the Secured Party’s legal representatives, assigns and successors;

AND this Release is governed by, and will be interpreted and construed in accordance with, the laws of the Province of British Columbia and the federal laws of Canada applicable therein.
