INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Assignment") is entered into as of October 31, 2022 by and between **The Worth Collection, Ltd**, a Delaware corporation ("Seller") and **Nirvana Brands Worldwide Ltd** ("Purchaser"), Amertrans Park, Bushey Mill Lane, Watford, WD24 7JG, United Kingdom, a United Kingdom private limited company. Purchaser and Seller are sometimes referred to herein as a "Party" and collectively as "Parties."

Purchaser and Seller are parties to that certain Bill of Sale dated as of the date hereof (the "Bill of Sale"), pursuant to which Purchaser agreed to purchase and acquire from Seller, and Seller agreed to sell, assign, transfer, convey and deliver to Purchaser, the Assets (as defined in the Bill of Sale);

All capitalized terms used herein which are not otherwise defined shall have the meaning given to such terms in the Bill of Sale; and

Seller and Purchaser now seek to consummate the sale, assign, transfer, conveyance and delivery of the Intellectual Property.

NOW, THEREFORE, in consideration of the promises and mutual agreements set forth in the Bill of Sale, the Parties hereby agree as follows:

1. **Assignment.** Effective as of the date first written above, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller has sold, assigned, transferred, conveyed and delivered, and does hereby sell, assign, transfer and convey to Purchaser all Intellectual Property and all rights associated therewith, including, but not limited to the specific registrations as set forth on Schedule A. "Intellectual Property" shall mean all (i) issued patents and patent applications (whether provisional or non-provisional), including divisionals, continuations, continuations-in-part, substitutions, reissues, reexaminations, extensions, or restorations of any of the foregoing, and other governmental authority-issued indicia of invention ownership (including certificates of invention, petty patents, and patent utility models) ("Patents"); (b) trademarks, service marks, brands, certification marks, logos, trade dress, trade names, and other similar indicia of source or origin, together with the goodwill connected with the use of and symbolized by, and all registrations, applications for registration, and renewals of, any of the foregoing ("Trademarks"); (c) copyrights and works of authorship, whether or not copyrightable, and all registrations, applications for registration, and renewals of any of the foregoing ("Copyrights"); (d) trade secrets, know-how, inventions (whether or not patentable), discoveries, improvements, technology, business and technical information, standard operating procedures, genetics, databases, data compilations and collections, tools, methods, processes, techniques, and other confidential and proprietary information and all rights therein ("Trade Secrets"); and (e) all other intellectual or industrial property and proprietary rights, (ii) all rights to file any future applications or registrations for, any of the Intellectual Property and (iii) all common law rights associated with the Intellectual Property; the same to be held and enjoyed by Purchaser for its own use and enjoyment, and

for the use and enjoyment of its successors, assigns, and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Seller if this assignment and sale had not been made, together with all claims by Seller for damages by reason of past infringement of the Intellectual Property or that arises from the Intellectual Property, with the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives. Seller shall, without further consideration, execute and deliver such additional documents and provide assistance reasonably required or requested by Purchaser, its successors and assigns, and their legal representatives (including, without limitation, execution and delivery of any affidavits, declarations, oaths, or other documents as may reasonably be required) to secure, vest, perfect, confirm, record, and enforce the rights granted to Purchaser under this Assignment.

2. **Proxy.** Purchaser may record this Agreement with the United States Patent and Trademark Office ("USPTO"), and with comparable offices in other jurisdictions throughout the world. All costs associated with any such registrations or recordations shall be paid by Purchaser. In the event that Seller is unable or unwilling to fully perform its obligations under this Assignment, to the extent necessary to perfect such right, title, and interest in and to Purchaser or as otherwise required, Seller hereby irrevocably designates and appoints Purchaser or its assign and their duly authorized officers and agents as Seller agents and attorneys-in-fact to act for and in Seller's behalf and instead of Seller, to execute and file any registration, application or other document and to do all other lawfully permitted acts in connection with the Intellectual Property.

3. **Severability.** If any term or provision of this Assignment is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Assignment or invalidate or render unenforceable such term or provision in any other jurisdiction. Upon such determination that any term or other provision is invalid, illegal, or unenforceable, the Parties shall negotiate in good faith to modify this Assignment so as to effect the original intent of the Parties as closely as possible in a mutually acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the greatest extent possible.

4. **Amendment and Modification; Waiver.** This Assignment may only be amended, modified, or supplemented by an agreement in writing signed by each Party. No waiver by any Party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the Party so waiving. No waiver by any Party shall operate or be construed as a waiver in respect of any failure, breach, or default not expressly identified by such written waiver, whether of a similar or different character, and whether occurring before or after that waiver. No failure to exercise, or delay in exercising, any right, remedy, power, or privilege arising from this Assignment shall operate or be construed as a waiver thereof; nor shall any single or partial exercise of any right, remedy, power, or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power, or privilege.

5. **Further Assurances.** Each of the Parties shall, and shall cause their respective affiliates to, execute, and deliver such additional documents, instruments, conveyances,

and assurances and take such further actions as may be reasonably required to carry out the provisions hereof and give effect to the transactions contemplated by this Assignment.

6. **Counterparts.** This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

7. **Governing Law; Submission to Jurisdiction; Waiver of Jury Trial.**

a) This Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of Laws of any jurisdiction other than those of the State of Delaware.

b) ANY LEGAL SUIT, ACTION OR PROCEEDING ARISING OUT OF OR BASED UPON THIS ASSIGNMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY OR THEREBY MAY BE INSTITUTED IN THE FEDERAL COURTS OF THE UNITED STATES OF AMERICA FOR THE DISTRICT OF DELAWARE OR THE COURTS OF THE STATE OF DELAWARE, AND EACH PARTY IRREVOCABLY SUBMITS TO THE EXCLUSIVE JURISDICTION OF SUCH COURTS IN ANY SUCH SUIT, ACTION, OR PROCEEDING. SERVICE OF PROCESS, SUMMONS, NOTICE, OR OTHER DOCUMENT BY MAIL TO SUCH PARTY'S ADDRESS SET FORTH HEREIN SHALL BE EFFECTIVE SERVICE OF PROCESS FOR ANY SUIT, ACTION, OR OTHER PROCEEDING BROUGHT IN ANY SUCH COURT. THE PARTIES IRREVOCABLY AND UNCONDITIONALLY WAIVE ANY OBJECTION TO THE LAYING OF VENUE OF ANY SUIT, ACTION, OR ANY PROCEEDING IN SUCH COURTS AND IRREVOCABLY WAIVE AND AGREE NOT TO PLEAD OR CLAIM IN ANY SUCH COURT THAT ANY SUCH SUIT, ACTION, OR PROCEEDING BROUGHT IN ANY SUCH COURT HAS BEEN BROUGHT IN AN INCONVENIENT FORUM.

8. **Successors and Assigns.** This Assignment shall be binding upon and shall inure to the benefit of the Parties and their respective successors and permitted assigns. No Party may assign its rights or obligations hereunder without the prior written consent of the other Party, which consent shall not be unreasonably withheld or delayed. No assignment shall relieve the assigning Party of any of its obligations hereunder. Notwithstanding the foregoing, (a) Purchaser may assign its rights under this Assignment, in whole or in part to one or more subsidiaries or affiliates of Purchaser, and such assignment shall not relieve Purchaser of its obligations hereunder, and (b) Purchaser may, if required by the lenders or

other entities providing financing to Purchaser or its affiliates, grant a security interest in, and collateral assignment of, its rights under this Assignment and the Bill of Sale to secure the obligations of Purchaser or such Affiliates to such lenders or such other entities.

9. **No Third-Party Beneficiaries.** This Assignment is for the sole benefit of the Parties and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other Person or entity any legal or equitable right, benefit, or remedy of any nature whatsoever under or by reason of this Assignment.


10. **Entire Agreement.** This Assignment and the Bill of Sale constitute the sole and entire agreement of the Parties to this Assignment with respect to the subject matter contained herein and therein, and supersede all prior and contemporaneous understandings and agreements, both written and oral, with respect to such subject matter.



INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Assignment") is entered into as of October 31, 2022 by and between **The Worth Collection, Ltd**, a Delaware corporation ("Seller") and **Nirvana Brands Worldwide Ltd** ("Purchaser"), Amertrans Park, Bushey Mill Lane, Watford, WD24 7JG, United Kingdom, a United Kingdom private limited company. Purchaser and Seller are sometimes referred to herein as a "Party" and collectively as "Parties."

Purchaser and Seller are parties to that certain Bill of Sale dated as of the date hereof (the "Bill of Sale"), pursuant to which Purchaser agreed to purchase and acquire from Seller, and Seller agreed to sell, assign, transfer, convey and deliver to Purchaser, the Assets (as defined in the Bill of Sale);

All capitalized terms used herein which are not otherwise defined shall have the meaning given to such terms in the Bill of Sale; and

Seller and Purchaser now seek to consummate the sale, assign, transfer, conveyance and delivery of the Intellectual Property.

NOW, THEREFORE, in consideration of the promises and mutual agreements set forth in the Bill of Sale, the Parties hereby agree as follows:

1. **Assignment.** Effective as of the date first written above, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller has sold, assigned, transferred, conveyed and delivered, and does hereby sell, assign, transfer and convey to Purchaser all Intellectual Property and all rights associated therewith, including, but not limited to the specific registrations as set forth on Schedule A. "Intellectual Property" shall mean all (i) issued patents and patent applications (whether provisional or non-provisional), including divisionals, continuations, continuations-in-part, substitutions, reissues, reexaminations, extensions, or restorations of any of the foregoing, and other governmental authority-issued indicia of invention ownership (including certificates of invention, petty patents, and patent utility models) ("Patents"); (b) trademarks, service marks, brands, certification marks, logos, trade dress, trade names, and other similar indicia of source or origin, together with the goodwill connected with the use of and symbolized by, and all registrations, applications for registration, and renewals of, any of the foregoing ("Trademarks"); (c) copyrights and works of authorship, whether or not copyrightable, and all registrations, applications for registration, and renewals of any of the foregoing ("Copyrights"); (d) trade secrets, know-how, inventions (whether or not patentable), discoveries, improvements, technology, business and technical information, standard operating procedures, genetics, databases, data compilations and collections, tools, methods, processes, techniques, and other confidential and proprietary information and all rights therein ("Trade Secrets"); and (e) all other intellectual or industrial property and proprietary rights, (ii) all rights to file any future applications or registrations for, any of the Intellectual Property and (iii) all common law rights associated with the Intellectual Property; the same to be held and enjoyed by Purchaser for its own use and enjoyment, and

for the use and enjoyment of its successors, assigns, and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Seller if this assignment and sale had not been made, together with all claims by Seller for damages by reason of past infringement of the Intellectual Property or that arises from the Intellectual Property, with the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives. Seller shall, without further consideration, execute and deliver such additional documents and provide assistance reasonably required or requested by Purchaser, its successors and assigns, and their legal representatives (including, without limitation, execution and delivery of any affidavits, declarations, oaths, or other documents as may reasonably be required) to secure, vest, perfect, confirm, record, and enforce the rights granted to Purchaser under this Assignment.

2. **Proxy.** Purchaser may record this Agreement with the United States Patent and Trademark Office ("USPTO"), and with comparable offices in other jurisdictions throughout the world. All costs associated with any such registrations or recordings shall be paid by Purchaser. In the event that Seller is unable or unwilling to fully perform its obligations under this Assignment, to the extent necessary to perfect such right, title, and interest in and to Purchaser or as otherwise required, Seller hereby irrevocably designates and appoints Purchaser or its assign and their duly authorized officers and agents as Seller agents and attorneys-in-fact to act for and in Seller's behalf and instead of Seller, to execute and file any registration, application or other document and to do all other lawfully permitted acts in connection with the Intellectual Property.

3. **Severability.** If any term or provision of this Assignment is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Assignment or invalidate or render unenforceable such term or provision in any other jurisdiction. Upon such determination that any term or other provision is invalid, illegal, or unenforceable, the Parties shall negotiate in good faith to modify this Assignment so as to effect the original intent of the Parties as closely as possible in a mutually acceptable manner in order that the transactions contemplated hereby be consummated as originally contemplated to the greatest extent possible.

4. **Amendment and Modification; Waiver.** This Assignment may only be amended, modified, or supplemented by an agreement in writing signed by each Party. No waiver by any Party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the Party so waiving. No waiver by any Party shall operate or be construed as a waiver in respect of any failure, breach, or default not expressly identified by such written waiver, whether of a similar or different character, and whether occurring before or after that waiver. No failure to exercise, or delay in exercising, any right, remedy, power, or privilege arising from this Assignment shall operate or be construed as a waiver thereof; nor shall any single or partial exercise of any right, remedy, power, or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power, or privilege.

5. **Further Assurances.** Each of the Parties shall, and shall cause their respective affiliates to, execute, and deliver such additional documents, instruments, conveyances,

and assurances and take such further actions as may be reasonably required to carry out the provisions hereof and give effect to the transactions contemplated by this Assignment.

6. **Counterparts.** This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.

7. **Governing Law; Submission to Jurisdiction; Waiver of Jury Trial.**

a) This Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of Laws of any jurisdiction other than those of the State of Delaware.

b) ANY LEGAL SUIT, ACTION OR PROCEEDING ARISING OUT OF OR BASED UPON THIS ASSIGNMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY OR THEREBY MAY BE INSTITUTED IN THE FEDERAL COURTS OF THE UNITED STATES OF AMERICA FOR THE DISTRICT OF DELAWARE OR THE COURTS OF THE STATE OF DELAWARE, AND EACH PARTY IRREVOCABLY SUBMITS TO THE EXCLUSIVE JURISDICTION OF SUCH COURTS IN ANY SUCH SUIT, ACTION, OR PROCEEDING. SERVICE OF PROCESS, SUMMONS, NOTICE, OR OTHER DOCUMENT BY MAIL TO SUCH PARTY'S ADDRESS SET FORTH HEREIN SHALL BE EFFECTIVE SERVICE OF PROCESS FOR ANY SUIT, ACTION, OR OTHER PROCEEDING BROUGHT IN ANY SUCH COURT. THE PARTIES IRREVOCABLY AND UNCONDITIONALLY WAIVE ANY OBJECTION TO THE LAYING OF VENUE OF ANY SUIT, ACTION, OR ANY PROCEEDING IN SUCH COURTS AND IRREVOCABLY WAIVE AND AGREE NOT TO PLEAD OR CLAIM IN ANY SUCH COURT THAT ANY SUCH SUIT, ACTION, OR PROCEEDING BROUGHT IN ANY SUCH COURT HAS BEEN BROUGHT IN AN INCONVENIENT FORUM.

8. **Successors and Assigns.** This Assignment shall be binding upon and shall inure to the benefit of the Parties and their respective successors and permitted assigns. No Party may assign its rights or obligations hereunder without the prior written consent of the other Party, which consent shall not be unreasonably withheld or delayed. No assignment shall relieve the assigning Party of any of its obligations hereunder. Notwithstanding the foregoing, (a) Purchaser may assign its rights under this Assignment, in whole or in part to one or more subsidiaries or affiliates of Purchaser, and such assignment shall not relieve Purchaser of its obligations hereunder, and (b) Purchaser may, if required by the lenders or

other entities providing financing to Purchaser or its affiliates, grant a security interest in, and collateral assignment of, its rights under this Assignment and the Bill of Sale to secure the obligations of Purchaser or such Affiliates to such lenders or such other entities.

9. **No Third-Party Beneficiaries.** This Assignment is for the sole benefit of the Parties and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or shall confer upon any other Person or entity any legal or equitable right, benefit, or remedy of any nature whatsoever under or by reason of this Assignment.

10. **Entire Agreement.** This Assignment and the Bill of Sale constitute the sole and entire agreement of the Parties to this Assignment with respect to the subject matter contained herein and therein, and supersede all prior and contemporaneous understandings and agreements, both written and oral, with respect to such subject matter.


