CONFIRMATION OF TRADEMARK ASSIGNMENT

This CONFIRMATION OF TRADEMARK ASSIGNMENT (the "Confirmation") is effective as of January 18, 2023 (the "Effective Date"), by and between PARK HOTELS & RESORTS INC., a Delaware corporation (the "Assignor"), and HILTON RESORTS CORPORATION, a Delaware corporation (the "Assignee").

WHEREAS, pursuant to Section 1.01(a) of the Contribution Agreement, dated as of October 24, 2016, among Assignor, Assignee and the other signatories party thereto (the "Contribution Agreement"), Assignor assigned, transferred and contributed to Assignee all right, title and interest of Assignor in the Timeshare Assets (as that term is defined in the Contribution Agreement), including the U.S. trademark registrations set forth on Schedule A hereto, together with the goodwill of the business associated therewith and all common law rights related thereto (the "Trademarks"), effective as of October 24, 2016;

NOW, THEREFORE, for good and valuable consideration (including that recited in the Contribution Agreement), the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee confirms as follows:

1. Assignor hereby confirms that it has irrevocably assigned, transferred and contributed to Assignee all of its right, title and interest in and to the Trademarks. Assignee shall hold all right, title and interest in and to the Trademarks as fully and exclusively as same would have been held and enjoyed by Assignor had the above-mentioned assignment not been made.

2. Each party hereto shall execute and deliver (or cause to be executed and delivered) such additional documents, certificates, and make (or cause to be made) any filings or notices that may be necessary or appropriate to consummate and make effective in the most expeditious manner practicable, this Confirmation and each party hereto shall take all such further action as may be necessary or appropriate to consummate and make effective, in the most expeditious manner practicable, this Confirmation.

3. This Confirmation will be governed by and construed in accordance with the laws of the State of Delaware applicable to agreements to be executed and performed within such state, without regard to the choice of law principles thereof.

4. This Confirmation may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.


