TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Termination and Release of Intellectual Property Security Agreement (this “*Termination*”), dated as of January 13, 2023, is executed by **ORIX GROWTH CAPITAL, LLC**, a Delaware limited liability company (“*Secured Party*”), in favor of **INVOCA, INC.**, a Delaware corporation (“*Grantor*”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreements (defined below).

RECITALS

A. Pursuant to that certain Intellectual Property Security Agreement, dated as of September 18, 2018 (the “*2018 Security Agreement*”), as supplemented by that certain Reaffirmation and Supplement to Intellectual Property Security Agreement, dated as of May 11, 2021 (the “*2021 Security Agreement*”), as supplemented by that certain Reaffirmation and Supplement to Intellectual Property Security Agreement, dated as of January 12, 2022 (the “*2022 Security Agreement*”, together with the 2018 Security Agreement and the 2021 Security Agreement, the “*Security Agreements*”), by and between Grantor and Secured Party, Grantor granted to Secured Party a security interest in the IP Collateral (defined below).

B. The 2018 Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on September 18, 2018, at Reel 046903 and Frame 0583, and with the Trademark Division of the United States Patent and Trademark Office on September 18, 2018, at Reel 6461 and Frame 0154, to evidence the security interest granted under the 2018 Security Agreement.

C. The 2021 Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on October 21, 2021, at Reel 057884 and Frame 0947, and with the Trademark Division of the United States Patent and Trademark Office on October 20, 2021, at Reel 007465 and Frame 0334, to evidence the security interest granted under the 2021 Security Agreement.

D. The 2022 Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on January 28, 2022, at Reel 058892 and Frame 0404, and with the Trademark Division of the United States Patent and Trademark Office on January 28, 2022, at Reel 007589 and Frame 0297, to evidence the security interest granted under the 2022 Security Agreement.

E. Secured Party agrees to execute this Termination in order to evidence the termination and release of its security interest in the IP Collateral specified below.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby agrees as follows:

(a) Secured Party expressly terminates and releases all of Secured Party’s right, title and interest in, to and under the following (collectively, the “*IP Collateral*”):

(i) Intellectual Property (including without limitation those copyrights, patents, trademarks and mask works listed on Schedules A, B and C hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.

(b) Secured Party represents and warrants that it has the full power and authority to execute this Termination.

(c) Secured Party authorizes and requests the patent and trademark divisions of the United States Patent and Trademark Office, and the United States Copyright Office, to record this Termination.


