TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

- (a) terminates the IP Agreements and terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and liens on and security interests in and to the entire right, title, and interest of Grantor in and to all of Grantor's Intellectual Property listed on Schedules A and B attached hereto, granted pursuant to the Loan Documents;
- (b) re-assigns, grants and re-conveys to the Grantor any and all of the right, title, and interest of Grantor that may have been acquired in and to all of Grantor's Intellectual Property listed on <u>Schedules</u> A and B; and
 - (c) authorizes the recordation of this Release with the USPTO, at Grantor's expense.

SECTION 3. <u>Choice of Law</u>. This Release shall be governed by and construed in accordance with the laws of the State of California, without regard to its conflict of laws principles.

SECTION 4. <u>Electronic Signatures</u>. This Release may be transmitted and/or signed by facsimile or other electronic transmission. The effectiveness of any such signature shall, subject to applicable Law, have the same force and effect as manually signed originals and shall be binding on the parties.
