TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("**Trademark Assignment**"), dated as of January 23, 2023, is made by Checkers Drive-In Restaurants, Inc. ("**Assignor**"), a Delaware Corporation, in favor of The Moody Bible Institute of Chicago ("**Assignee**"), a not-for-profit Illinois Corporation, having an address at 820 N LaSalle Blvd Chicago, IL 60610.

WHEREAS, Assignee wishes to acquire from Assignor the marks shown in U.S. Reg. Nos. 6639986 (FRIES ARE OUR LOVE LANGUAGE) and 6349602 (OUR LOVE LANGUAGE) (the "Assigned Trademarks"); and

WHEREAS, Assignor is willing to assign the Assigned Trademarks to Assignee and has agreed to execute and deliver this Trademark Assignment for recording by Assignee with the United States Patent and Trademark Office;

NOW THEREFORE, Assignor and Assignee agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in and to the following:

(a) Registration No. 6639986 for the FRIES ARE OUR LOVE LANGUAGE mark and US Trademark Registration No. 6349602 for the OUR LOVE LANGUAGE mark and all issuances, extensions, and renewals thereof, together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks;

(b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

2. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment upon request by Assignee. Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned Trademarks to Assignee, or any assignee or successor thereto.

3. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.

4. Successors and Assigns. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

5. Governing Law. This Trademark Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Trademark Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Illinois without giving effect to any choice or conflict of law provision or rule.
