**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of January 20, 2023 ("Release"), is made by Pacific Western Bank, a California state chartered bank ("Bank"), in favor of Theragen, Inc., a Delaware corporation ("Grantor").

**WHEREAS**, pursuant to that certain Intellectual Property Security Agreement entered into as of September 19, 2017 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") and recorded at the United States Patent and Trademark Office ("USPTO") recorded on September 25, 2017 at Reel 6160 Frame 0496, by and between the Grantor and Bank, Grantor pledged and granted to the Bank a security interest in and continuing lien on all of Grantor's right, title and interest in, to and under all Intellectual Property Collateral (as defined in the Security Agreement), including, but not limited to, the trademarks listed on Schedule A hereto.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Bank hereby states as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement.

**SECTION 2. Termination and Release.** Bank hereby:

(a) absolutely, unconditionally and irrevocably terminates the Security Agreement;

(b) absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to Grantor's right, title and interest in, to and under the Intellectual Property Collateral, including, but not limited to, the trademarks listed on Schedule A attached hereto;

(c) represents and warrants that it has full authority to execute and deliver this Release; and

(d) authorizes the recordation of this Release with the USPTO at Grantor's expense.
