TERMINATION AND RELEASE OF SECURITY INTEREST

This **TERMINATION AND RELEASE OF SECURITY INTEREST**, dated as of January 23, 2023 ("Release"), is made by WINTRUST BANK, an Illinois state chartered bank ("Lender"), in favor of ARGENTUM MEDICAL, LLC, a Delaware limited liability company ("Grantor").

WHEREAS, Agent, Grantor, and certain other parties have entered into that certain Confirmatory Grant of Security Interest in Intellectual Property, dated as of January 20, 2017 (as from time to time amended, restated, supplemented or otherwise modified, the "Confirmatory Security Agreement");

WHEREAS, pursuant to the Confirmatory Security Agreement, Grantor granted to Lender, to secure its obligations under the Security Agreement, a security interest in all right, title and interest of Grantor in and to certain intellectual property;

WHEREAS, the Confirmatory Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on January 20, 2017 at Reel 5972 Frame 0074; and

WHEREAS, Grantor has satisfied the terms of the Confirmatory Security Agreement and requests a specific release of the security interest granted and recorded against its intellectual property.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:

(a) terminates the Confirmatory Security Agreement and terminates, cancels, discharges, and releases all of its security interests in and to all right, title and interest of Grantor in and to all intellectual property, whether granted pursuant to the Confirmatory Security Agreement or otherwise (and including, but not limited to, the Trademarks listed on Schedule A attached hereto);

(b) assigns and transfers to Grantor all of its right, title and interest in and to all intellectual property, whether granted pursuant to the Confirmatory Security Agreement or otherwise (including, but not limited to the Trademarks listed on Schedule A attached hereto), together with the goodwill of the business symbolized thereby; and

(c) authorizes the recordation of this Release with the USPTO or any similar office or agency within or outside the United States at the Grantor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Illinois.
