RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (“Release”) is made as of this 23rd day of January, 2023, by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, the “Agent”), pursuant to that certain Trademark Security Agreement, dated as of January 31, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among EDEN CREAMERY, LLC d/b/a Halo Top Creamery, a California limited liability company (the “Grantor”) and the Agent and recorded with the United States Patent and Trademark Office on January 31, 2020 at Reel/Frame 6853/0198. Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Security Agreement.

WHEREAS, pursuant to the Security Agreement, the Grantor granted and pledged to the Agent, for the benefit of each member of the Lender Group and each of the Bank Product Providers, a continuing security interest in all of the Grantor’s right, title and interest in and to (a) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party, including those Trademarks listed on Schedule A attached hereto; (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and (c) all products and proceeds (as that term is defined in the Code) of the foregoing, including any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademarks exclusively licensed under any Intellectual Property License, including right to receive damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any Trademark Intellectual Property License (the “Trademark Collateral”).

WHEREAS, the Agent wishes to: (a) release and terminate all of its security interest covering the Trademark Collateral; (b) restore all right, title and interest in and to the Trademark Collateral to the Grantor; and (c) terminate any and all liens and encumbrances respecting the Trademark Collateral under the Security Agreement.

WHEREAS, the Grantor has requested that the Agent execute and deliver this Release to evidence the release of its security interest in the Trademark Collateral for filing and recordation with the United States Patent and Trademark Office.

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby irrevocably release and terminate all liens and security interests granted by the Grantor in favor of the Agent in the Trademark Collateral, and does hereby discharge, quit claim and relinquish unto the Grantor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademark Collateral under the Security Agreement.
