**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made as of December 20, 2022 by and between DK Crown Holdings Inc. (f/k/a DraftKings Inc.), a Delaware corporation (“Grantor”) and Pacific Western Bank, a California state-chartered bank (“Grantee”).

WHEREAS, Grantor and Grantee are parties to that certain Amended and Restated Loan and Security Agreement dated as of October 21, 2016 (as amended, restated, or otherwise modified from time to time, the “Loan and Security Agreement”), pursuant to which Grantor granted Grantee a security interest in Grantor’s Collateral (as defined in the Loan and Security Agreement).

WHEREAS, in conjunction with the Loan and Security Agreement, Grantor and Grantee entered into that certain Amended and Restated Intellectual Property Security Agreement, dated as of October 21, 2016 (as amended, modified, restated or supplemented from time to time, the “IP Security Agreement”) pursuant to which Grantor granted Grantee a security interest in the intellectual property set forth on Exhibit A attached hereto (collectively, the “IP Collateral”); and

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on October 28, 2016 at Reel/Frame 5909/0590, on February 7, 2017 at Reel/Frame 5984/0771, on July 5, 2018 at Reel/Frame 6403/0223, and on August 21, 2019 at Reel/Frame 6725/0413 and Reel/Frame 050115/0625.


WHEREAS, Grantor wishes to terminate, cancel, and release its security interest in the IP Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee agrees as follows:

1. Release of Security Interest. Grantee hereby irrevocably and forever terminates, releases and discharges any and all security interests and liens in the intellectual property granted by Grantor prior to the date of this Release, and agrees and acknowledges that all of such rights and interests of Grantee to such intellectual property are hereby terminated and released.
2. Recordation of Release. Grantee understands and agrees that this Release may be recorded with the United States Patent and Trademark Office and any cost and expense of such recordation shall be borne solely by Grantor.
3. Further Actions. Grantee further agrees to cooperate with Grantor and to provide Grantor with the information and additional authorization reasonably required to effect the release of Grantee’s security interest in the intellectual property described herein, provided that any necessary documents are to be prepared by counsel to Grantee and the reasonable and documented cost and expense of such documents and actions shall be borne solely by Grantor.
