
FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, VANGUARD INTERNATIONAL SOLUTIONS INC, a Georgia corporation (the “Grantor”), hereby grants to THE HUNTINGTON NATIONAL BANK, as Agent (in such capacity, “Agent”), for the benefit of the Secured Parties (as defined below), a continuing security interest in (i) all of the Grantor’s right, title and interest in, to and under the United States trademarks, trademark registrations and trademark applications (the “Marks”) set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT is made to secure the satisfactory performance and payment in full when due of all the Obligations, as such term is defined in the Credit and Security Agreement, dated as of the date hereof, by and among the Grantor, Vanguard International Solutions, LLC, a Florida limited liability company, Agent, Issuer (as defined therein) and the Lenders (as defined therein) from time to time party thereto (as amended, restated, supplemented or otherwise modified and in effect from time to time, the “Credit Agreement”). The rights and remedies of Agent with respect to the security interest granted herein are as set forth in the Credit Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this grant are deemed to conflict with the Credit Agreement, the provisions of the Credit Agreement shall govern. As used herein, “Secured Parties” means, collectively, Agent, Issuer (as defined in the Credit Agreement) and the Lenders (as defined in the Credit Agreement).
