RELEASE OF SECURITY INTERESTS IN TRADEMARKS

WHEREAS, Collateral Agent, pursuant to that certain Trademark Security Agreement recorded in the United States Patent and Trademark Office on August 8, 2018, at Reel 6407, Frame 0731, a security in and to the Trademark Collateral (as that term is defined by that certain Trademark Security Agreement), including the trademarks and trademark registrations specifically listed on Schedule A attached hereto and the goodwill associated therewith (collectively, the trademarks, registrations and goodwill comprise the “Marks”); and


WHEREAS, Collateral Agent wishes to absolutely, unconditionally, irrevocably and forever release, terminate, cancel and discharge the security interest under the aforementioned Trademark Security Agreement and interest in and to the Trademark Collateral, including all of the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and upon the terms set forth in this release, the Collateral Agent agrees and hereby (i) absolutely, unconditionally, irrevocably and forever releases, terminates, cancels and discharges, all of its rights in, to and under, including its Lien on and the security interest in, and right of set off against, the aforementioned Trademark Security Agreement and interest in and to the Trademark Collateral, including all of the Marks, and (ii) reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in, to and under the Trademark Collateral and the Marks to the Grantor.


