WHEREAS, pursuant to that certain Bill of Sale and Assignment and Assumption Agreement made effective by and between Assignor and Assignee as of December 12, 2022, Assignor assigned to Assignee various business assets, including but not limited to the following four trademarks referred to collectively herein the "Assigned Property":

DYNAMIC for use with "sports clothing, namely, athletic team uniforms for men's and women's soccer, volleyball, field hockey, lacrosse, tennis, baseball, softball, basketball, football, track and hockey, and athletic socks and athletic hosiery for soccer, hockey and general sports use," in International Class 25, and registered with the USPTO under Registration No. 2861869, granted on July 13, 2004; and

D DYNAMIC (Stylized) for use with "athletic team uniforms, namely, jerseys, shorts, pants," in International Class 25, and registered with the USPTO under Registration No. 4728228, granted on April 28, 2015;

WHEREAS, Assignor and Assignee now wish to confirm the assignment of the Assigned Property, the USPTO Trademark Electronic Search System ("TESS") records for which are attached hereto as Exhibit A:

NOW, THEREFORE, in return for good and valuable consideration exchanged between the parties, the receipt and adequacy of each party acknowledges, Assignor and Assignee hereby agree as follows:

This Assignment will be construed in accordance with, and any and all actions arising hereunder will be governed by, the laws of the Commonwealth of Virginia (without regard to its choice-of-law rules) and, to the extent applicable, the trademark laws of the United States of America.

3. Execution. This Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. 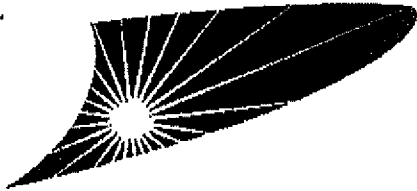
