TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment"), effective January 6, 2023, is made by and among GERM GUARDS INCORPORATED, a New York corporation ("Assignor"), and GREENER HOLDCO INC., a corporation incorporated under the laws of the province of Ontario, Canada ("Assignee"), with a principal place of business located at Unit 5 - 5004 Timberlea Boulevard, Mississauga, Ontario, Canada, L4W 5C5.

WHEREAS, Assignor is the registered owner of the trademark and the associated trademark registration set forth on Schedule 1 attached hereto (hereinafter the "Mark").

WHEREAS, Assignee has agreed to acquire from Assignor, and Assignor has agreed to assign to Assignee, all of Assignor's right, title and interest in and to the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as set forth below.

1. Trademark Assignment. Assignor does hereby assign, sell, transfer and convey, unto Assignee all of Assignor's right, title and interest in and to the Mark, including all rights under common law, and the goodwill appurtenant thereto. Assignor agrees to execute and deliver at the request of Assignee all necessary documents, papers, instruments, and assignments in order to assign the Mark to Assignee, and to perform any other reasonable acts Assignee may require in order to vest all of Assignor's rights, title, and interest in and to the Mark in Assignee and to provide evidence to support any of the foregoing in the event such evidence is reasonably deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.
2. Miscellaneous. This Assignment may be executed in one or more counterparts, each of which will be deemed an original, but all of which will be considered one instrument. This Assignment and all matters relating to this Assignment will be governed by New York law.

IN WITNESS WHEREOF, the parties by their duly authorized representatives have executed this Trademark Assignment effective as of the Effective Date.


