**INTELLECTUAL PROPERTY PARTIAL RELEASE**

This Intellectual Property Partial Release is entered into as of January 30, 2023 by GLAS TRUST CORPORATION LIMITED, as collateral agent (in such capacity, the “Collateral Agent”) for the Secured Parties pursuant to that certain Security Agreement, dated as of July 26, 2022 (as amended prior to the date hereof), by and among INVACARE CORPORATION, the Collateral Agent, and the other parties thereto.

INVACARE CORPORATION, an Ohio corporation (“Invacare”), together with FREEDOM DESIGNS, INC., a California corporation (each a “Grantor” and collectively the “Grantors”) and the Collateral Agent are party to, among other things, a Trademark Security Agreement entered into as of July 26, 2022 (the “Trademark Security Agreement”), whereby the Grantors granted to the Collateral Agent a security interest in the Trademark Collateral as defined therein, including the Trademarks set forth in Schedule I hereto.

The Trademark Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on August 9, 2022, at Reel 7802, Frame 0231.


Invacare has requested that the Collateral Agent release its security interest in the Trademark Collateral specifically described and limited to the Trademarks listed on Schedule I hereto (the “Specified Trademark Collateral”).

ACCORDINGLY, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged the undersigned agrees to the above Recitals and as follows:

1. As used herein, terms defined in the Trademark Security Agreement and not otherwise defined herein have the meanings given them in the Trademark Security Agreement.
2. The Collateral Agent hereby irrevocably releases its security interest in the Specified Trademark Collateral specifically described and set forth on Schedule 1 hereto. The Collateral Agent retains its security interest in all other Trademark Collateral as set forth in the Trademark Security Agreement.
3. The Collateral Agent hereby reassigns, grants and conveys to Invacare, without any representation, warranty, recourse or undertaking by the Collateral Agent, all of the Collateral Agent’s right, title and interest in and to the Specified Trademark Collateral specifically described and set forth on Schedule 1 hereto.
