TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made and entered into as of January 10, 2023, ("Effective Date"), by and between Hill-Rom Holdings, Inc, a corporation organized and existing under the laws of the state of Indiana ("Assignor") and Camp Farm LLC a limited liability company organized and existing under the laws of the State of Ohio ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, transfers, assigns, conveys and delivers to Assignee: (i) its rights, title and interests in and to the Marks, including any ownership interests Assignor may have or claim to have in the Marks (whether now existing or hereafter created or acquired), together with all goodwill associated with and symbolized by the Marks and any common law rights in and to the Marks, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all claims for damages by reason of past, present or future infringement or other violation or unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

Assignor authorizes and requests the Commissioner of Trademarks or other responsible official to record Assignee as owner of the Marks, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns, or other legal representatives.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


To the extent any provision herein is inconsistent with the Agreement, the provisions of the Agreement shall control.


