## TRADEMARK ASSIGNMENT

WHEREAS, Innovative Data Systems, Inc., a New York corporation (“Assignor”), is the owner of record of the United States trademark identified in Schedule 1 attached hereto (the “Mark”), which is the subject of the United States trademark registration listed in such Schedule 1;

WHEREAS, Assignor is party to that certain Asset Purchase Agreement, dated August 30, 2022 (the “Purchas Agreement”), by and between Assignor and 48forty Solutions, LLC (the “Assignee”);

WHEREAS, pursuant to the Purchase Agreement, Assignor sold, transferred, and assigned to Assignee, and Assignee purchased and assumed from Assignor, substantially all of Assignor’s assets, including, without limitation, the Mark; and

WHEREAS, the purpose of this Trademark Assignment is to memorialize the assignment of the Mark together with the related goodwill from Assignor to Assignee pursuant to the Purchase Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns unto Assignee all of Assignor’s rights, title and interest in and to the Mark, together with (a) the goodwill of the business symbolized by and associated with the Mark, (b) all applications for registration, registrations, renewals and statements of use thereof, and (c) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Mark or the registrations thereof or such associated goodwill.


