Assignor further agrees to take all reasonable and necessary steps to implement the provisions of the Assignment, including executing and reasonably aiding in the preparation of any documents that are reasonable and necessary to obtain and perfect the assignment, assignment recordals, and registration of the U.S. and foreign trademarks and trademarks applications subject to this Assignment; provided that this Assignment and any documents referenced above are subject, in all respects, to the terms, limitations, exceptions and




