**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "*Termination and Release*") is granted as of December 29, 2022 by and **DELAWARE TRUST COMPANY**, as successor to **VIRTUS GROUP, LP**, as Administrative Agent (the "*Agent*"), in favor of **RTS HOLDINGS, LLC**, a Delaware limited liability company (the "*Grantor*").

**WHEREAS**, the Grantor executed and delivered a Memorandum of Security Interest in Trademarks, dated as of January 2, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Agreement*"), granting to the Agent a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademarks (as defined in the Agreement), which was recorded with the United States Patent and Trademark Office ("*USPTO*") on January 2, 2019, at Reel 6515, Frame 0312;

**WHEREAS**, Grantor has requested that the Agent terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

**WHEREAS**, Grantor has requested that the Agent provide a document suitable for recording with the USPTO to evidence such release.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests in Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including, without limitation, those trademarks and trademarks applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK IN ACCORDANCE WITH SECTION 5-1401 OF THE GENERAL OBLIGATIONS LAW OF THE STATE OF NEW YORK.
