TERMINATION AND RELEASE OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS ("*Termination and Release*") dated as of December 29, 2022, is made by EAST WEST BANK ("*EWB*"), as agent (in such capacity, together with its successors and permitted assigns, the "*Agent*"), in favor of each of SAN DIEGO FARMS LLC, a Delaware limited liability company (the "*Grantor*"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Assignment of Security Interest in Trademarks (defined below) or the Successor Agent Agreement (defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Resignation of Agent and Appointment of Successor Agent dated as of December 1, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "*Successor Agent Agreement*"), by and among Grantor, as the Borrower, SAN DIEGO FARMS HOLDINGS LLC, a Delaware limited liability company ("*Holdings*"), the lenders from time to time party thereto (each a "*Lender*" and, collectively, the "*Lenders*"), EWB, as Successor Agent and AVANTE MEZZANINE PARTNERS SBIC II, L.P., as Resigning Agent, Resigning Agent executed that certain Assignment of Security Interest in Trademarks, dated as of December 1, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "*Assignment of Security Agreement*"), which was recorded in the United States Patent and Trademark Office (the "*USPTO*") at Reel 007128 Frame 0075, pursuant to which Resigning Agent assigned to the Agent for the benefit of the Secured Parties, and transferred to the Agent for the benefit of the Secured Parties (i) all of its rights, powers, privileges, duties and obligations as "*Agent*" under the Trademark Security Agreement (which was recorded at the USPTO at Reel 6680 Frame 0336), including those with respect to the Trademark Collateral (as defined in the Trademark Security Agreement) and (ii) all of the liens and security interest, granted to, or in favor of, the Resigning Agent under the Trademark Security Agreement in the Trademark Collateral, including the Trademarks listed on Schedule A attached hereto; and

WHEREAS, Agent now desires to terminate the Trademark Security Agreement and terminate and release its security interest in the Trademark Collateral, including the trademarks and/or trademark applications listed on Schedule A attached hereto and reassign any and all rights, title, and interest in the same to Grantor.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby (a) releases its security interest in all of the Trademark Collateral, including Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on Schedule A and (b) terminates the Trademark Security Agreement. Agent authorizes the recordation of this Termination and Release with the USPTO.

2. If and to the extent that Agent has acquired any right, title or interest in or to any of the Trademarks set forth on Schedule A, Agent hereby reassigns, grants and conveys to Grantor,


without any representation, warranty, recourse or undertaking by Agent, any and all of Agent's right, title, and interest in and to such Trademarks.
