TERMINATION AND RELEASE
OF
TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination") is dated as of January 4, 2023, and made by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (the "Agent"), in favor of TOUCHPOINTCARE, LLC, an Illinois limited liability company (the "Grantor").

WHEREAS, Grantor and Agent entered into that certain Trademark Security Agreement, dated as of December 21, 2020 (the "Security Agreement"), in which a security interest (the "Security Interest") was granted by Grantor in favor of Agent in certain Trademarks and Trademark Collateral;

WHEREAS, the Security Agreement was originally recorded in the Trademark Division of the United States Patent and Trademark Office ("USPTO") on December 21, 2020, at Reel 7141, Frame 0866; and

WHEREAS, the Grantor has requested that the Agent execute and deliver this release to evidence the release of the Security Interest in the Trademarks and Trademark Collateral for recordation with the USPTO.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Agent hereby states as follows:

1. Definitions. The terms "Trademarks" and "Trademark Collateral", as used herein, shall have the respective meanings set forth in the Security Agreement, or, if not defined therein, in the Pledge and Security Agreement dated as of October 21, 2019 (including all exhibits thereto, as amended, restated, amended and restated, supplemented or otherwise modified) and shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in and to such Trademarks and Trademark Collateral, including in the trademarks listed on Schedule A attached hereto.

2. Release of Security Interest. The Agent hereby terminates the Security Agreement, and irrevocably terminates, releases and discharges the Security Interest in the Trademarks and Trademark Collateral and reassigns to Grantor all right, title and interest that any Grantor may have in and to the Trademarks and the Trademark Collateral without recourse and without any representation or warranty.

3. Recordation. The Agent authorizes the Grantor and their designees to record this Termination with the USPTO or any other applicable governmental authority at the Grantor's expense.
