TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS (this "Termination"), is dated as of January 31, 2023, and made by **MANUFACTURERS AND TRADERS TRUST COMPANY** (the "Grantee"), to **A & A ASSOCIATES, LLC**, a New York limited liability company, and **ABLE EQUIPMENT RENTAL, INC.**, a New York corporation (each a "Grantor" and collectively, the "Grantors").

WHEREAS, pursuant to those Trademark Security Agreements dated as of April 29, 2019 and March 2, 2020, made by Grantors in favor of Grantee (the "Security Agreements"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreements were recorded with the trademark division of the United States Patent and Trademark Office on May 8, 2019 at Reel/Frame 6639/0736 and on March 2, 2020 at Reel/Frame 6880/0121;

WHEREAS, Grantee now desires to terminate the Security Agreements and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.
2. Release of Security Interest. Grantee hereby terminates the Security Agreements and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.


