## ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (“Assignment”), effective as of December 13, 2022, is made by and between SODO Apparel, Inc., a Washington corporation, with an address of 55 South Atlantic Street, #407, Seattle, WA 98134, by and through its court-appointed receiver, TurningPointe, LLC d/b/a Turning Point (“**Receiver**”, and together with SODO Apparel, Inc., the “**Assignor**”), and SODO Athletic Lab, Inc., a Delaware corporation, with an address of 251 Little Falls Drive, Wilmington, DE 19808 (“**Assignee**”).

WHEREAS, SODO Apparel, Inc. is the registrant and owner of record for Trademark Reg. Nos. **5,672,400** for SODO and **4,503,393** for SODO (the “**Trademarks**”), together with the goodwill of the business symbolized by and associated with the Trademarks;

WHEREAS, the Superior Court of Washington for King County on August 24, 2022 in proceeding No. 22-2-13329-5 SEA appointed Receiver to be the general receiver for all assets of SODO Apparel, Inc., which includes the Trademarks;

WHEREAS, Assignor and Assignee have entered into a certain Asset Purchase Agreement, dated as of October 21, 2022 (the “Purchase Agreement”), pursuant to which Assignor has agreed to transfer and assign to Assignee, and Assignee has agreed to purchase, all of Assignor’s right, title and interest in and to Trademarks, together with the goodwill of the business symbolized by and associated with the Trademarks; and

WHEREAS, pursuant to the Purchase Agreement, the parties have agreed to execute further documents in order for the parties to carry out the intent of the Purchase Agreement, which includes the assignment to Assignee of the Trademarks, together with the goodwill of the business symbolized by and associated with the Trademarks.


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, transfers, conveys and assigns to Assignee all of Assignor’s right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by and associated with the Trademarks, and the right to sue and collect for past infringement.
