**SECOND AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT**

**THIS SECOND AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT** (this “*Agreement*”), dated as of February 1, 2023, is made by each of the entities listed on the signature pages hereof (each a “*Grantor*” and, collectively, the “*Grantors*”), in favor of **FARRAGUT SBIC FUND II, LP**, a Delaware limited partnership, as the collateral agent (in such capacity, together with its successors and assigns, the “*Agent*”) for the lenders under the Loan Agreement (as defined below).

**WHEREAS, AIR FLOW RESEARCH HEADS, LLC**, a Delaware limited liability company (“*Company*”), **SCAT ENTERPRISES, LLC**, a Delaware limited liability company (“*SCAT*”), **RACETEC PISTONS, LLC**, a Delaware limited liability company (f/k/a RaceTec Holdings, LLC) (“*RaceTec*”), and immediately upon consummation of the Vortech Acquisition, **VORTECH ENGINEERING, INC.**, a Delaware corporation (“*Vortech DE*”), **AIRPOWER GROUP, INC.**, a California corporation (“*Airpower*”), **PAXTON AUTOMOTIVE CORP.**, a California corporation (“*Paxton*”), **VORTECH ENGINEERING, INC.**, a California corporation (“*Vortech CA*”), and **VORTRON TECHNOLOGIES, INC.**, a California corporation (“*Vortron*” and, together with Vortech DE, Airpower, Paxton and Vortech CA, individually and collectively, “*New Borrower*”; and, together with Company, SCAT and RaceTec, individually and collectively, the “*Borrower*”), are each a borrower under that certain Loan Agreement dated as of June 28, 2021 among the Borrower, Parent, Intermediate Holdco and the other Guarantors party thereto, the Lenders party thereto, and the Agent (as amended, amended and restated, supplemented, or otherwise modified from time to time, the “*Loan Agreement*”); and

**WHEREAS**, the Borrower, Intermediate Holdco and Parent are party to that certain Security Agreement dated as of June 28, 2021 in favor of the Agent (as amended, amended and restated, supplemented, or otherwise modified from time to time, the “*Security Agreement*”).

**NOW, THEREFORE**, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

**SECTION 1. Defined Terms.** Except as otherwise expressly defined herein, all capitalized terms used in this Agreement shall have the meanings ascribed to them in the Security Agreement and, if not defined therein, in the Loan Agreement. Any term used in the UCC and not defined in this Agreement, the Security Agreement, or the Loan Agreement shall have the meaning given to such term in the UCC.

**SECTION 2. Security Interest.** Subject to Section 25 of the Security Agreement, as security for the Obligations, each Grantor hereby grants to the Agent (for the benefit of the Lenders) a continuing first priority security interest in and to and a lien on all of such Grantor’s right, title, and interest, whether now existing or hereafter arising or acquired, in and to its Trademarks, including but not limited to the Trademarks listed on Exhibit A attached hereto (the “*Collateral*”). Each Grantor hereby requests that the U.S. Commissioner of Patents and

Trademarks record this Agreement with respect to the U.S. Trademarks listed on Exhibit A attached hereto.

SECTION 3. **Incorporation by Reference**. Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

SECTION 4. **Counterparts**. This Agreement may be executed in any number of counterparts and by the different parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all of which shall together constitute one and the same instrument.


SECTION 5. **Amendment and Restatement**. Grantors and Agent are entering into this Agreement to satisfy their mutual desire to amend and restate that certain Amended and Restated Trademark Security Agreement dated as of December 16, 2021 previously entered into by Company in favor of Agent (as amended, restated, supplemented or otherwise modified from time to time, the "***Prior Trademark Security Agreement***"). It is the intention of the parties hereto that this Agreement shall not effectuate a novation of the indebtedness, obligations and liabilities of Parent or Borrower to Agent and Lenders under the Prior Trademark Security Agreement, but merely constitute a restatement and, where applicable, a substitution of the terms governing such indebtedness, obligations and liabilities. Parent and Borrower hereby confirm the security interest granted by Parent and Borrower, as applicable, in favor of Agent to secure all such indebtedness, obligations and liabilities owing by Parent and Company, as applicable, to Agent and Lenders pursuant to the Prior Trademark Security Agreement (except as modified herein).
