## **CONFIRMATORY TRADEMARK ASSIGNMENT**

This CONFIRMATORY TRADEMARK ASSIGNMENT, effective December 5, 2022 (the "Assignment"), is entered into by and among PARKER-HANNIFIN CORPORATION, an Ohio corporation ("Assignor"), and EKSO BIONICS HOLDINGS, INC., a Nevada corporation ("Assignee").

WHEREAS, Assignor was the sole and exclusive owner of the common law trademarks, U.S. trademark applications, and U.S. trademark registrations registered on the Principal Register of the United States Patent and Trademark Office listed in Schedule A attached hereto (the "Assigned Marks").

WHEREAS, Assignee desired to acquire all rights, titles and interests in and to the Assigned Marks, together with the goodwill associated therewith,

WHEREAS, the parties wish to execute this Assignment to confirm that the Assigned Marks have been transferred to the Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. *Assignment.* Assignor does hereby transfer, assign, convey and deliver to Assignee all right, title and interest in and to the Assigned Marks, together with the goodwill associated therewith, including, without limitation all of the rights in damages for past, present and future infringements in the Assigned Marks, provided that, with respect to the United States intent-to-use trademark application set forth on Schedule A hereto, the transfer of such application accompanies, pursuant to the Asset Purchase Agreement dated December 5, 2022, the transfer of Seller's business portion of the business to which the trademark pertains, and that business is ongoing and existing.

2. *Recordation.* Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States to record ownership of the Assigned Marks as the property of Assignee.

3. *Counterparts.* This Assignment may be executed in one or more counterparts and delivered electronically (including by electronic .pdf submission), each of which shall be deemed an original and all of which shall constitute one and the same instrument.
