**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of February 2, 2023, by **BMO HARRIS BANK N.A.**, a United States national association (in such capacity, together with its successors and assigns, “Collateral Agent”) **ENDEAVOR CARPE DIEM, LLC**, a Delaware limited liability company with an address at 9350 South Dixie Highway, Suite 950 Miami, FL 33156, **ENDEAVOR PLUS, LLC**, a Delaware limited liability company with an address at 9350 South Dixie Highway, Suite 950 Miami, FL 33156, **ENDEAVOR SCHOOLS, LLC**, a Delaware limited liability company with an address at 9350 South Dixie Highway, Suite 950 Miami, FL 33156, **ES CRANIUM, LLC**, a Delaware limited liability company with an address at 9350 South Dixie Highway, Suite 950 Miami, FL 33156, and **ES KHM OPCO, LLC**, a Delaware limited liability company with an address at 9350 South Dixie Highway, Suite 950 Miami, FL 33156 (each, a “Grantor” and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into a certain Trademark Security Agreement dated June 17, 2022 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on June 17, 2022 at the United States Patent and Trademark Office at Reel 7756, Frame 0845.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantors granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of its right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, including all of the goodwill of each Grantor’s business symbolized by the Trademark Collateral and associated therewith, and assigns, transfers and conveys to the Grantors any interest in such intellectual property, including the Security Interest.
