TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT is entered into as of February 2, 2023 (this “**Agreement**”), by and among AMASS Brands Inc, a Delaware corporation (“**AMASS**”), Project Crush Acquisition Corp LLC, a Delaware limited liability company (“**Crush Acquisition**”; and together with AMASS, each a “**Grantor**”, and collectively, the “**Grantors**”), and the lenders listed on Schedule I attached hereto (each a “**Lender**”, and collectively, the “**Lenders**”).

Reference is made to that certain (i) Loan Agreement, dated as of January 23, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time and in effect on the date hereof, the “**Loan Agreement**”), among AMASS, as the borrower, and the Lenders, pursuant to which each Lender has extended credit to the Borrowers subject to the terms and conditions set forth therein, and (ii) Security Agreement, dated as of January 23, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time and in effect on the date hereof, the “**Security Agreement**”), among the Grantors, certain other Pledgors (as defined therein) party thereto, and the Lenders. Consistent with the requirements set forth in the Loan Agreement and the Security Agreement, the parties hereto agree as follows:

SECTION 1. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Loan Agreement.

SECTION 2. As security for the prompt and complete payment or performance, as the case may be, in full of the obligations, each Grantor, pursuant to the Security Agreement, did and hereby does pledge, collaterally assign, mortgage, transfer and grant to the Lenders, its successors and assigns, a continuing security interest in all of its right, title or interest in, to and under all of the following assets, whether now owned by or owing to, or hereafter acquired by or arising in favor of such Grantor, and regardless of where located (collectively, the “**Trademark Collateral**”):

- A. all trademarks, including those trademark registrations and registration applications in the United States Patent and Trademark Office listed on Schedule II hereto;
- B. all goodwill associated with or symbolized by the foregoing;
- C. the right to sue third parties for past, present and future infringements, dilutions or violations of the foregoing; and
- D. all proceeds of and any right associated with the foregoing;

provided that Trademark Collateral shall not include any (i) “intent-to-use” applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. §1051, unless and until an Amendment to Allege Use or a Statement of Use under Section 1(c) or 1(d) of the Lanham Act has been filed, or (ii) AMASS’ four percent (4%) legal and beneficial ownership interest in all right, title and interest in and to the Original Marks and associated trademark rights, and any future trademarks (whether registered or unregistered) for use in connection with the products associated with, or in the same line as, the Original Marks. “Original Marks” mean: (a) International Registration No. 1420521; (b) International Application No. A0095910; (c) Australian Registration No. 2038671; and (d) U.S. Trademark Application No. 88/864,935 and U.S. Trademark Registration No. 5,498,634.

SECTION 3. The security interests granted to the Lenders herein are granted in furtherance, and not in limitation of, the security interests granted to the Lenders pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Lenders with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Loan Agreement or Security Agreement, the terms of the Loan Agreement or Security Agreement shall govern.

SECTION 4. This Agreement shall be governed by, and construed in accordance with, the laws of the State of California.

SECTION 5. All of the agreements, conditions, covenants, provisions and stipulations contained in the loan documents to be kept and performed by the Pledgors are by this reference hereby made part of this Agreement to the same extent and with the same force and effect as if they were fully set forth in this Agreement, and each Grantor covenants and agrees to keep and perform the same, or cause the same to be kept and performed, in accordance with their terms.
