**NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made as of December 22, 2022, by JPMORGAN CHASE BANK, N.A., as Administrative Agent (in such capacity, the “Administrative Agent”), in favor of CONCORD BICYCLE ASSETS, LLC, a Delaware limited liability company (“Concord Bicycle”), CONCORD MUSIC GROUP, INC., a Delaware corporation (“Concord Music”), KIDZ BOP ENTERPRISES LLC, a Delaware limited liability company (“Kidz Bop”), and RODGERS & HAMMERSTEIN HOLDINGS LLC, a Delaware limited liability company (“Rodgers & Hammerstein” and, together with Concord Bicycle, Concord Music and Kidz Bop, the “Grantors” and each a “Grantor”).

**WITNESSETH:**

WHEREAS, pursuant to (i) the Amended and Restated Credit, Security, Pledge and Guaranty Agreement, dated as of October 27, 2017 (as amended by Amendment No. 1 and Waiver, dated as of May 31, 2018, by Amendment No. 2 and Consent to Credit Agreement, dated as of November 6, 2018, by Amendment No. 3 to Credit Agreement, dated as of July 20, 2020, by Amendment No. 4 to Credit Agreement, dated as of August 14, 2020, and as further amended, supplemented or otherwise modified, renewed or replaced from time to time, the “Credit Agreement”), among the Alchemy Copyrights, LLC, a Delaware limited liability company, and Boosey & Hawkes Holdings Limited, a company organized under the laws of England and Wales, as Borrowers, each of the other guarantors party thereto, the Administrative Agent, and each of the other parties from time to time a party thereto and (ii) that certain Trademark Security Agreement (Trademarks, Trademark Registrations, and Trademark Applications), dated as of August 14, 2020 (the “Trademark Security Agreement”), between and among the Grantors and the Administrative Agent, each Grantor granted to the Administrative Agent (for the benefit of the Secured Parties), a continuing first priority security interest (the “Security Interest”) in and to all of such Grantor’s right, title and interest in, to and under the Trademark Collateral (as that term is defined in the Trademark Security Agreement, but excluding any Excluded Assets), then owned, then existing or thereafter arising, adopted or acquired and whether or not in possession of such Grantor, including, without limitation, the Trademarks listed on Schedule 1 attached hereto, if any, to secure the due and punctual payment and performance of its obligations under and in connection with its guaranty of the Obligations, subject only to Permitted Encumbrances;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 21, 2020 at Reel 7031, Frame 0176; and

WHEREAS, the Grantors have requested and the Administrative Agent has agreed to release its Security Interest in the Trademark Collateral (as that term is defined in the Trademark Security Agreement), including, without limitation, the Trademarks listed on Schedule 1 attached hereto, if any.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent agrees as follows:

1. Definitions. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement or the Credit Agreement, as applicable.

2. Release. The Administrative Agent, without recourse, representation or warranty of any kind, hereby releases, terminates, discharges, and cancels its Security Interest in and to the Trademark Collateral arising under the Trademark Security Agreement and the Credit Agreement, including, without limitation, the Trademarks listed on Schedule 1 attached hereto, if any, and any right, title or interest of the Administrative Agent in the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule 1 attached hereto, if any, arising under the Trademark Security Agreement or the Credit Agreement, as applicable, shall hereby cease and become void. The Administrative Agent, without recourse, representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreement.

3. Recordation. The Administrative Agent, at the Grantors' sole cost and expense, hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Release.

4. Governing Law. THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND THE APPLICABLE FEDERAL LAWS OF THE UNITED STATES OF AMERICA, WITHOUT REGARD TO ANY CONFLICT OF LAWS PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.
