CERTIFICATE OF AMENDMENT OF
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION**

Pursuant to Section 242 of the General Corporation Law of the State of Delaware, Stanley Convergent Security Solutions, Inc., a corporation duly organized and existing under the General Corporation Law of the State of Delaware (the "Corporation") does hereby certify:

FIRST: That the Board of Directors of Stanley Convergent Security Solutions, Inc., by unanimous written consent of its members adopted a resolution proposing and declaring advisable the following amendment to the Amended and Restated Certificate of Incorporation of said corporation:

Article I of the Amended and Restated Certificate of Incorporation:

RESOLVED, that the Certificate of Incorporation be amended to change the name of the Company from "Stanley Convergent Security Solutions, Inc." to "Securitas Technology Corporation" and that, to that end, Article I of the Certificate of Incorporation be deleted in its entirety and the following new Article I be substituted in lieu thereof:

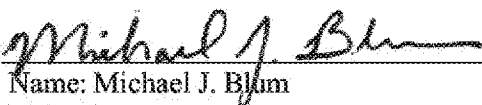
"**Article I.** The name of the Corporation is Securitas Technology Corporation (the "Corporation")."
