SHORT FORM
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “IP Security Agreement”), dated as of January 27, 2023, is made by the Persons listed on the signature pages hereof (collectively, the “Makers”) in favor of Impact Prosperity Partners, LLC, as the agent under the Promissory Note referred to below (the “Agent”). Capitalized terms used herein and not otherwise defined herein shall have the meanings assigned to such terms in the Promissory Note (as defined below).

Reference is made to that certain Senior Secured Promissory Note, dated as of January 13, 2023 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Promissory Note”), by and between the Makers, Agent, and each lender from time to time party thereto, pursuant to which the Lenders have severally agreed to make Loans to the Makers upon the terms and subject to the conditions therein.

WHEREAS, under the terms of the Promissory Note, the Makers have granted to the Agent, for the benefit of the Lenders, a security interest in, among other property, certain intellectual property of the Makers, and have agreed as a condition thereof to execute this IP Security Agreement for recording with the United States Patent and Trademark Office and the United States Copyright Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Maker agrees as follows:

SECTION 1. Grant of Security. Each Maker hereby grants to the Agent for the benefit of the Lenders a Security Interest in all of such Maker’s right, title and interest in and to the following (the “Collateral”):

- (a) all Patents, including the issued and pending Patents in the United States Patent and Trademark Office that are set forth in Schedule A hereto;
- (b) all Trademarks, including the registered Trademarks and Trademarks for which applications are pending in the United States Patent and Trademark Office that are set forth in Schedule B hereto (excluding any Excluded Property); and
- (c) all Copyrights, including the Copyrights registered in the United States Copyright Office that are set forth in Schedule C hereto;
- (d) all Proceeds and products of the foregoing; and
- (e) all causes of action arising prior to or after the date hereof for infringement of any of the Copyrights, Patents and Trademarks, or unfair competition regarding the same (in the case of Trademarks).

SECTION 2. Security for Obligations. The grant of a security interest in the Collateral by each Maker under this IP Security Agreement secures the payment of all Obligations of such Maker now or hereafter existing under or in respect of the Loan Documents, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise. Without limiting the generality of the foregoing, this IP Security Agreement secures, as to each Maker, the payment of all amounts that constitute part of the secured Obligations and that would be owed by such Maker to any Lender under the

Loan Documents but for the fact that such secured Obligations are unenforceable or not allowable due to the existence of a bankruptcy, reorganization or similar proceeding involving a Maker.

SECTION 3. Recordation. This IP Security Agreement has been executed and delivered by the Makers for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office and the United States Copyright Office. Each Maker authorizes and requests that the Register of Copyrights, Commissioner for Patents and the Commissioner for Trademarks record this IP Security Agreement.

SECTION 4. Execution in Counterparts. This IP Security Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 5. Grants, Rights and Remedies. This IP Security Agreement has been entered into in conjunction with the provisions of the Promissory Note. Each Maker does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Agent with respect to the Collateral are more fully set forth in the Promissory Note, the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this IP Security Agreement and the terms of the Promissory Note, the terms of the Promissory Note shall govern.


SECTION 6. GOVERNING LAW. THIS IP SECURITY AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.

SECTION 7. Severability. In case any one or more of the provisions contained in this IP Security Agreement should be held invalid, illegal or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions contained herein and in the Promissory Note shall not in any way be affected or impaired thereby (it being understood that the invalidity of a particular provision in a particular jurisdiction shall not in and of itself affect the validity of such provision in any other jurisdiction). The parties hereto shall endeavor in good-faith negotiations to replace the invalid, illegal or unenforceable provisions with valid provisions the economic effect of which comes as close as possible to that of the invalid, illegal or unenforceable provisions.


