**TERMINATION AND RELEASE OF SECURITY  
INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of January 11, 2023 ("Release"), is made by **Massachusetts Mutual Life Insurance Company** ("MMLIC") in favor of **Foodservices Brand Group, LLC (f/k/a/ COHG Acquisition, LLC)** ("FBG") as assignee of **Tomlinson Industries, LLC**, a Delaware Limited Liability Company ("Tomlinson") and together with **FBG**, "Grantor").

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated August 29, 1996, between Grantor and MMLIC (the "Security Agreement"), Grantor granted to MMLIC a continuing security interest in all right, title and interest of Grantor in and to all Trademarks, including the Trademarks identified on the attached Schedule A hereto;

**WHEREAS**, the security interest identified herein was recorded with the United States Patent and Trademark Office ("USPTO") on August 29, 1996, at Reel 001501 Frame 0261; and

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, MMLIC and Grantor agree as follows:

**SECTION 1. Defined Terms**. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement referenced in the preamble and recitals hereto.

**SECTION 2. Termination and Release**. MMLIC, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

- (a) terminates, cancels, discharges and releases the continuing security interest, to the extent they exist in, Grantor's right, title, and interest in and to the Trademarks, including those identified on Schedule A attached hereto, granted pursuant to the Security Agreement; and
- (b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law**. This Release shall be governed by and construed in accordance with the laws of the State of New York.


