**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) made as of February 8, 2023, is granted by Capital One, National Association, in its capacity as the Collateral Agent (as defined in the Security Agreement (as defined below)) for itself and certain lenders (in such capacity, the “**Assignee**”), in favor of True Blue Car Wash, LLC, a Delaware limited liability company (the “**Assignor**”).

**WHEREAS**, by (i) that certain Pledge and Security Agreement, dated as of October 17, 2019, made by the Assignor and the other grantors from time to time party thereto in favor of the Assignee (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) and (ii) that certain Assignment For Security – Trademarks, dated as of October 17, 2019, made by the Assignor in favor of the Assignee (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Trademark Security Agreement**”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Trademark Security Agreement, as applicable), the Assignor granted to the Assignee, for the benefit of the Assignee and the other Secured Parties, a continuing security interest in the Collateral (as defined in the Trademark Security Agreement), including the Trademarks set forth on **Schedule A** hereto;

**WHEREAS**, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on October 17, 2019, at Reel 6774, Frame 0121; and

**WHEREAS**, the Assignee has agreed to release, discharge, relinquish, terminate and dissolve its security interest in and continuing lien on all of the Assignor’s right, title and interest in, to and under the Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Assignee hereby, on behalf of itself and the other Secured Parties, states and agrees as follows:

1. **Release of Security Interest.** The Assignee hereby, without recourse, representation, warranty or other assurance of any kind, releases and discharges its security interests in the Collateral, and any right, title or interest of the Assignee in the Collateral hereby ceases and becomes void.
2. **Further Assurances.** The Assignee agrees to execute and deliver to the Assignor any and all further documents and instruments, and do any and all further acts which the Assignor (or its respective agents or designees) reasonably request (at the Assignor’s sole cost and expense) in order to confirm this Release.
3. **Recordation of Release.** The Assignee hereby authorizes the Assignor (or the Assignor’s authorized representative(s)) to record this Release with the United States Patent and Trademark Office.


4. Governing Law. This Release shall be governed by and construed in accordance with the internal laws (but not the laws of conflicts) of the State of New York.
