INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of November 8, 2022 (this “IP Security Agreement”), is made by and among the grantors listed on the signature pages hereto (each a “Grantor”, and collectively, the “Grantors”), and REGIONS BANK, in its capacity as administrative agent and collateral agent (the “Administrative Agent”) on behalf of the Lenders (as defined below).

W I T N E S S E T H:

A. **WHEREAS**, pursuant to that certain Credit Agreement, dated as of the date hereof (as may be amended, restated, amended and restated, supplemented, extended or otherwise modified from time to time, the “Credit Agreement”), by and among Authentic Brands LLC, a Delaware limited liability company (“Authentic Brands”), Black Rifle Coffee Company LLC, a Delaware limited liability company (“BRCC”), Good Beans LLC, a Delaware limited liability company (“Good Beans”), Free Range American Media Company LLC, a Delaware limited liability company (“Free Range”), Signal Mountain Media Works LLC, a Texas limited liability company (“Signal Mountain”), 1144 SLC LLC, a Delaware limited liability company (“1144 SLC”), BRCC Operating Company LLC, a Delaware limited liability company (“BRCC Operating”), Spencer 355 LLC, a Delaware limited liability company (“Spencer 355”), and 621 Manchester LLC, a Delaware limited liability company (“621 Manchester” and, together with Authentic Brands, BRCC, Good Beans, Free Range, Signal Mountain, 1144 SLC, BRCC Operating, Spencer 355 and any other Person that may become Borrowers pursuant to Section 8.14 of the Credit Agreement, jointly and severally, the “Borrowers” and, each, a “Borrower”), the financial institutions from time to time party thereto (each, a “Lender” and, collectively, the “Lenders”), Regions Bank, an Alabama bank, in its capacities as a Lender, the Swing Line Lender and LC Issuer and Administrative Agent, the Lenders, Swing Line Lender and LC Issuer have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth in the Credit Agreement and other Loan Documents.

B. **WHEREAS**, pursuant to that certain Security Agreement, dated of the date hereof (as may be amended, restated, amended and restated, supplemented, extended or otherwise modified from time to time, the “Security Agreement”), among Borrowers, the other Credit Parties party thereto from time to time, and Administrative Agent, the Borrowers and the other Credit Parties granted Administrative Agent, for the benefit of the Secured Parties, a Lien in the Collateral (including the IP Collateral (as defined below));

C. **WHEREAS**, to induce Administrative Agent and Lenders to make extensions of credit to the Borrowers, the Grantors are required to execute and deliver to the Administrative Agent this IP Security Agreement.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:

1. **DEFINED TERMS**. All capitalized terms used herein but not otherwise defined herein or in the above recitals have the meanings given to them in the Credit Agreement or the Security Agreement, as applicable.

2. GRANT OF SECURITY INTEREST IN IP COLLATERAL. Each Grantor hereby grants to the Administrative Agent (for itself and on behalf of the Secured Parties) a continuing first priority security interest in all of such Grantor's right, title, and interest in, to, and under the following, whether presently existing or hereafter created or acquired (collectively, the "IP Collateral"):

(a) all of its patents and all patent licenses providing for the grant by or to such Grantor of any right under any patent, including, without limitation, those referred to on Schedule I hereto;

(i) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing; and

(ii) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof;

(b) all of its trademarks and all trademark licenses providing for the grant by or to such Grantor of any right under any trademark, including, without limitation, those referred to on Schedule II hereto;

(i) all renewals and extensions of the foregoing;

(ii) all goodwill of the business connected with the use of, and symbolized by, each such trademark; and

(iii) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof; and

(c) all of its copyrights and all copyright licenses providing for the grant by or to such Grantor of any right under any copyright, including, without limitation, those referred to on Schedule III hereto;

(i) all renewals and extensions of the foregoing; and

(ii) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

3. SECURITY FOR OBLIGATIONS. This IP Security Agreement and the security interest created hereby secures the payment and performance of all the Obligations, whether now existing or arising hereafter. Without limiting the generality of the foregoing, this IP Security Agreement secures the payment of all amounts which constitute part of the Obligations and would be owed by the Grantors to the Administrative Agent and the Lenders whether or not they are

unenforceable or not allowable due to the existence of any bankruptcy, insolvency proceeding, receivership, or similar case involving any Grantor.

4. SECURITY AGREEMENT. This IP Security Agreement has been executed and delivered by the Grantors for the purpose of registering the security interest of the Administrative Agent in the IP Collateral with the United States Patent and Trademark Office and the United States Copyright Office. The security interests granted pursuant to this IP Security Agreement are granted in conjunction with, and not in limitation of, the security interests granted to the Administrative Agent pursuant to the Credit Agreement and the Security Agreement, and the Credit Agreement and the Security Agreement (and all rights and remedies of the Administrative Agent and the Lenders thereunder) shall remain in full force and effect in accordance with their terms. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent and the Lenders with respect to the security interest in the IP Collateral made and granted hereby are more fully set forth in the Credit Agreement and the Security Agreement, in each case, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. The Credit Agreement and the Security Agreement (and all rights and remedies of the Administrative Agent and the Lenders thereunder), in each case, shall remain in full force and effect in accordance with its terms. To the extent there is a conflict between the Credit Agreement, the Security Agreement and this IP Security Agreement, the Credit Agreement or the Security Agreement, as applicable, shall control.

5. AUTHORIZATION TO SUPPLEMENT. If any Grantor shall obtain rights to any new patents, trademarks and/or copyrights, the provisions of the Credit Agreement, the Security Agreement and this IP Security Agreement shall automatically apply thereto. Without limiting the Grantors' obligations under this Section 5, each Grantor hereby authorizes the Administrative Agent unilaterally to modify this IP Security Agreement by amending the schedules hereto to include any such new patent, trademark and/or copyright rights of such Grantor. Notwithstanding the foregoing, no failure to so modify this IP Security Agreement or amend the schedules hereto shall in any way affect, invalidate or detract from the Administrative Agent's continuing security interest in all IP Collateral, whether or not listed on the schedules hereto.

6. COUNTERPARTS. This IP Security Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same instrument. In proving this IP Security Agreement or any other Loan Document in any judicial proceedings, it shall not be necessary to produce or account for more than one such counterpart signed by the party against whom such enforcement is sought. Any signatures delivered by a party by facsimile transmission or by e-mail transmission shall be deemed an original signature hereto.




