Declaration of Christine Lebrón-Dykeman in Support of Request to Correct Chain of Title

I, Christine Lebrón-Dykeman, state and declare:

1. I am an attorney with McKee, Voorhees & Sease, P.L.C. I am attorney of record for Assignor, C2O Pure Coconut Water, LLC and Assignee, C2O Coconut Water, LLC, and I am competent to testify and make this declaration of my personal knowledge.

2. The Assignment recorded on February 11, 2021, at Reel/ Frame 7189/0475 erroneously identified the citizenship of the Assignee limited liability company as Texas instead of Delaware. Additionally, the cover sheet erroneously identified the Assignee C2O Pure Coconut Water, LLC instead of C2O Coconut Water, LLC.

3. In an attempt to correct the errors in this Assignment/Coversheet, on August 24, 2021, a second assignment was recorded at Reel/Frame 7419/0571.

4. Even though the second recorded Assignment shows the correct Assignor/Assignee information, I have been advised by the PTO that it failed to clear the chain of title because of the errors in the original assignment/cover sheet. In other words, Assignment 2 (at Reel/ Frame 7189/0475) was not expunged and thus still shows in the chain of title.

5. Pursuant to TMEP 503.06(b), I am requesting a correction to the chain of title to accurately reflect that the Assignor of Trademark Registration Nos. 3806258 for the mark C2O and 4194572 for the mark Live Rejuvenated! was C2O Pure Coconut Water, LLC a Delaware limited liability company and the Assignee was C2O Coconut Water, LLC, a Delaware limited liability company.

6. Attached hereto is a marked up copy of the February 11, 2021 Cover Sheet and Assignment showing the errors to be corrected.

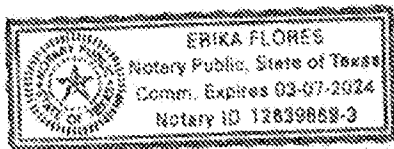

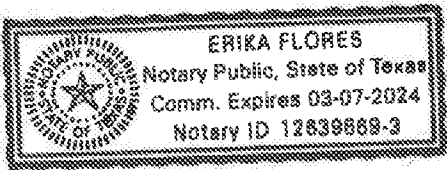


