EXHIBIT A-1  
TRADEMARK ASSIGNMENT  
(Seller to Buyer)

This Trademark Assignment (this “**Trademark Assignment**”), dated as of November 1, 2022 (“**Effective Date**”), is made by and between Colorfin, L.L.C., a Pennsylvania limited liability company (“**Assignor**”) and Golden Artist Colors Inc., a New York corporation (the “**Assignee**”).

**WHEREAS**, Assignor owns all right, title and interest in and to the marks set forth on Schedule A attached hereto and incorporated herein by reference (collectively, the “**Marks**”);

**WHEREAS**, Assignor and Assignee, among others, are both parties to that Asset Purchase Agreement dated of the Effective Date (“**Purchase Agreement**”) whereby Assignor has agreed to sell, assign, transfer, convey and deliver to Assignee all of its Seller IP, which includes the Marks;

**WHEREAS**, pursuant to the Purchase Agreement, Assignee has agreed to accept said assignment of the Seller IP, including the Marks; and

**NOW, THEREFORE**, in consideration of the representations, warranties, covenants and agreements contained in this Trademark Assignment and for other good and valuable consideration, the receipt and adequacy of which hereby are acknowledged, and intending to be legally bound hereby, the parties hereby agree as follows:

1. **Defined Terms**. All capitalized terms used and not otherwise defined in this Trademark Assignment (including the Schedule attached hereto) shall have the same meanings as set forth in the Purchase Agreement.

2. **Assignment**. Assignor hereby irrevocably sells, assigns, transfers, and conveys to Assignee, and Assignee hereby accepts from Assignor, all of Assignor’s right, title, and interest in and to the Marks, free and clear of all Liens, together with the goodwill of the business symbolized by the Marks, with the right to recover for damages and profits and all other remedies for past infringements thereof, including without limitation, the following:

- a. The Marks and all issuances, extensions and renewals thereof;
- b. All rights of Assignor of any kind whatsoever accruing under or relating to the Marks provided by applicable law, by international treaties and conventions and otherwise, including common law rights; and
- c. Any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to the Marks.

3. **Recordation**. Assignor hereby authorizes the Commissioner of the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Trademark Assignment upon request by Assignee.

4. **Assignability; Binding Effect**. This Trademark Assignment may not be assigned by any party hereto without the prior written consent of the other parties; provided, however, that Assignee may assign all or any part of its rights hereunder to any current or future affiliate of Assignee without the consent of the other parties; but no such assignment shall relieve Assignee of its obligations to the other parties

hereunder. Subject to the foregoing, this Trademark Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns. Any purported assignment in violation of this Trademark Assignment shall be void.

5. **Governing Law.** The laws of the State of New York, without regard to its principles of conflicts of laws, will govern the validity of this Trademark Assignment, the construction of its terms and the interpretation and enforcement of the rights and duties of the parties hereto. All actions and proceedings relating directly or indirectly to this Trademark Assignment shall be litigated exclusively: (i) if Buyer or a Buyer Indemnified Party commences an action, in any state court or federal court located in the State of New York; and (ii) if a Seller Party or Seller Indemnified Party commences an action, the Commonwealth of Pennsylvania. The parties hereto expressly consent to the jurisdiction of any such court and to venue therein.

6. **Amendment and Waivers.** Any term or provision of this Trademark Assignment may be amended or waived only by a writing signed by the party to be bound thereby. The waiver by a party of any breach hereof will not be deemed to constitute a waiver of any other default or any succeeding breach or default.

7. **Further Assurances.** At any time and from time to time after the date hereof, each party shall use commercially reasonable efforts to take all further actions and shall execute and deliver, or cause to be executed and delivered, to each other such other instruments of transfer or assignment as the other party may reasonably request to carry out the intent and purposes of this Trademark Assignment including, without limitation, any instruments of transfer or assignment for any contract of any Assignor that such Assignor and Assignee jointly determine was inadvertently omitted from Schedule A.

8. **Acknowledgments.** This Trademark Assignment is made subject to the representations and warranties of Seller Parties contained in the Purchase Agreement. The terms of the Purchase Agreement, including but not limited to, Seller Parties' representations, warranties, covenants, agreements and indemnities relating to the Seller IP and other matters, are incorporated herein by this reference. Assignor, as one of the Seller Parties in the Purchase Agreement, acknowledges and agrees that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

9. **Counterparts.** This Trademark Assignment may be executed in any number of counterparts, each of which will be an original as regards any party whose signature appears thereon and all of which together will constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile transmission or by e-mail of a .pdf attachment shall be effective as delivery of a manually executed counterpart of this Trademark Assignment. This Trademark Assignment will become binding when one or more counterparts hereof, individually or taken together, will bear the signatures of all the parties reflected hereon as signatories.
