**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of January 23, 2023, is made by **JPMORGAN CHASE BANK, N.A.**, as Administrative Agent (the "Administrative Agent" or the "Grantee") under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement, the Security Agreement (as defined below), or the IP Security Agreements (as defined below), as applicable), in favor of the Grantor (as defined below).

**WHEREAS**, in connection with that certain Credit Agreement, dated as of April 16, 2021 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), among Evriholder Products, LLC, an Indiana limited liability company (the "U.S. Borrower"), Murray Sales Inc. (f/k/a Joie Acquisition, Inc.), a company incorporated and organized under the laws of Quebec (the "Canadian Borrower"), Joie Holdings, Inc., a company incorporated and organized under the laws of Quebec, Evriholder Acquisition, Inc., a Delaware corporation, the Lenders from time to time party thereto and the Administrative Agent, the Lenders agreed to make loans and extend other financial accommodations to or for the benefit of the U.S. Borrower and the Canadian Borrower;

**WHEREAS**, the U.S. Borrower (the "Grantor") and the other parties party thereto entered into that certain Pledge and Security Agreement, dated as of April 16, 2021 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Security Agreement"), in favor of the Administrative Agent;

**WHEREAS**, in connection with the Credit Agreement and pursuant to the Security Agreement and those certain agreements described on Annex I attached hereto (collectively, the "IP Security Agreements"), the Grantor collaterally pledged and granted to the Administrative Agent, on behalf of and for the benefit of the Secured Parties, a security interest in all of the Grantor's right, title and interest in and to its Patents, Trademarks, and Copyrights (collectively, the "IP Collateral"); and

**WHEREAS**, the IP Security Agreements were recorded in the United States Patent and Trademark Office, the United States Copyright Office or the Canadian Intellectual Property Office, as applicable, on the dates and on the reels/frames or volume/document no., as applicable, set forth on Annex I attached hereto.


