**INTELLECTUAL PROPERTY PARTIAL RELEASE**

This Intellectual Property Partial Release is entered into as of January 30, 2023 by NATIONAL CITY BANK, as multicurrency collateral agent (in such capacity, the “Collateral Agent”) for the lenders referenced in that certain U.S. Security and Pledge Agreement, dated as of February 12, 2007 (as amended prior to the date hereof), by and among the Obligor party thereto, the Collateral Agent, and the lenders referenced therein.

INVACARE CORPORATION, an Ohio corporation (“Invacare”) and Collateral Agent executed that certain Notice of Grant of Security Interest in Trademarks (as amended prior to the date hereof, the “Trademark Notice Agreement”), whereby notice was given to the United States Patent and Trademark Office that Collateral Agent was granted a security interest in the trademarks and trademark applications set forth therein, including the trademarks set forth in Schedule I hereto.

The Trademark Notice Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office at Reel 3499, Frame 0262.

Invacare has requested that the Collateral Agent release its security interest in the trademarks listed on Schedule I hereto (the “Specified Trademark Collateral”).

ACCORDINGLY, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged the undersigned agrees to the above Recitals and as follows:

1. As used herein, terms defined in the Trademark Notice Agreement and not otherwise defined herein have the meanings given them in the Trademark Notice Agreement.
2. The Collateral Agent hereby irrevocably releases its security interest in the Specified Trademark Collateral specifically described and set forth on Schedule 1 hereto. The Collateral Agent retains its security interest in all other trademarks as set forth in the Trademark Notice Agreement.
3. The Collateral Agent hereby reassigns, grants and conveys to Invacare, without any representation, warranty, recourse or undertaking by the Collateral Agent, all of the Collateral Agent’s right, title and interest in and to the Specified Trademark Collateral specifically described and set forth on Schedule 1 hereto.
