SECOND SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

This Second Supplement to Trademark Security Agreement (this "Second Supplement") dated as of February 16, 2023 by each of the signatories hereto (collectively, the "Trademark Grantors"), is in favor of Pathlight Capital LP, as collateral agent (in such capacity, the "Agent") for the Credit Parties.

WHEREAS, the Trademark Grantor executed and delivered a Trademark Security Agreement, dated as of November 12, 2020 and recorded on November 12, 2020 at Reel 7104, Frame 0622 (as amended of record from time to time hereinafter, including pursuant to the First Supplement (defined below), the "Trademark Security Agreement") in favor of the Agent, pursuant to which the Trademark Grantor pledged, assigned and granted a security interest in certain trademarks and trademark applications (the "Marks");

WHEREAS, the Trademark Grantor executed and delivered a First Supplement to Trademark Security Agreement dated as of August 3, 2021 and recorded on August 3, 2021 at Reel 7376, Frame 0706 (as amended of record from time to time hereafter, the "First Supplement") in favor of the Agent, pursuant to which the Trademark Grantor pledged, assigned and granted a security interest in certain additional Marks; and

WHEREAS, the Trademark Grantor developed additional Marks and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Marks in favor of the Agent.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Trademark Security Agreement.
2. Supplement to Schedule 1. Schedule 1 to the Trademark Security Agreement is hereby supplemented, but not replaced, by Schedule 1-A annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Trademark Security Agreement remain in full force and effect. The Trademark Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This Second Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
