**Release of Grant of Security Interest in Trademark Rights**

This Release of Grant of Security Interest in Trademark Rights, dated as of February 1, 2023 (the “Release”), is made by Antares Capital LP, as collateral agent (in such capacity, the “Collateral Agent”) in favor of LB USA FLEXIBLES, INC. (formerly known as DAVID S. SMITH AMERICA INC.), a Delaware corporation, and LIQUI-BOX FLEXIBLES, INC. (formerly known as DSS RAPAK, INC.), a Delaware corporation (both a “Grantor” and collectively the “Grantors”).

WHEREAS, by (i) that certain Security Agreement, dated as of February 26, 2020, in favor of Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related Grant of Security Interest in Trademark Rights, dated as of February 27, 2020, in favor of Agent (as amended, restated, or modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 29, 2020 at Reel 6878, Frame 0846, the Grantors granted to Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantors’ right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantors desire Collateral Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral, including, without limitation, the Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Collateral, including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantors any and all of its rights, title and interests in the Collateral.

The Collateral Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
