**NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST  
(INTELLECTUAL PROPERTY)**

This NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST (INTELLECTUAL PROPERTY), dated as of February 15, 2023 (this “Notice”), is entered into among BARCLAYS BANK PLC (“Barclays”), as the resigning Administrative Agent, the resigning Collateral Agent, the resigning Swingline Lender and as the resigning Letter of Credit Issuer under the Credit Agreement (as defined below) (in such capacities, collectively, the “Resigning Agent”), ROYAL BANK OF CANADA (“RBC”), as the successor Administrative Agent and the successor Collateral Agent (in such capacities, the “Successor Agent”) and as the successor Swingline Lender and successor Letter of Credit Issuer under the Credit Agreement pursuant to the Resignation, Waiver, Consent and Appointment Agreement (defined below) , DESERT NEWCO, LLC, a Delaware limited liability company (“Holdings”), GO DADDY OPERATING COMPANY, LLC, a Delaware limited liability company (“Go Daddy”) and GD FINANCE CO, LLC (f/k/a GD Finance Co, Inc.), a Delaware limited liability company (“GD” and, together with Go Daddy, collectively, the “Borrowers”).

**WHEREAS**, the Borrowers, Holdings, the Lenders and the Resigning Agent, have entered into the Second Amended and Restated Credit Agreement dated as of February 15, 2017 (as amended by Amendment No. 1, dated as of November 22, 2017, as amended by the Joinder And Amendment Agreement, dated as of June 4, 2019, as amended by Amendment No. 3, dated as of October 3, 2019, as amended by Joinder and Fourth Amendment Agreement, dated as of August 10, 2020, as amended by Fifth Amendment Agreement, dated as of March 8, 2021, as amended by Joinder and Sixth Amendment Agreement, dated as of November 10, 2022 (“Amendment No. 6”) and as further amended, restated, supplemented or otherwise modified, refinanced or replaced from time to time, the “Credit Agreement”);

**WHEREAS**, pursuant to the Credit Documents (as defined in the Credit Agreement), the Borrowers granted to Resigning Agent a security interest in certain collateral;

**WHEREAS**, the Resigning Agent and applicable Borrowers entered into one or more Intellectual Property Security Agreements as identified on Schedule A attached hereto (the “IP Security Agreements”).

**WHEREAS**, the IP Security Agreements were recorded with the United States Patent and Trademark Office and United States Copyright Office as identified on Schedule A attached hereto; and

**WHEREAS**, pursuant to the Resignation, Waiver, Consent and Appointment Agreement dated as of November 10, 2022 entered into by and among the Resigning Agent, the Successor Agent, Holdings and the Borrowers (the “Resignation, Waiver, Consent and Appointment Agreement”) and Amendment No. 6, the Resigning Agent resigned as, and Successor Agent was appointed and accepted appointment as the Administrative Agent with all the rights, powers, privileges and duties of the Resigning Agent as Collateral Agent under the applicable Loan Documents, including in and to the IP Security Agreements.

**NOW, THEREFORE**, the parties agree as follows:

1. **Defined Terms.** Capitalized terms used herein without definition shall have the meanings attributed to such terms in the Resignation, Waiver, Consent and Appointment Agreement, Credit Agreement or other Credit Documents, as applicable.
2. **Succession and Replacement of Agency.** Pursuant to the terms and conditions set forth in the Resignation, Waiver, Consent and Appointment Agreement and Amendment No. 6, the Resigning

Agent has ceased to be the Agent under the Credit Documents and is succeeded to and replaced by the Successor Agent as Agent under the Credit Documents, and the Resigning Agent transferred, assigned, granted and conveyed unto the Successor Agent all of its right, title and interest in and to the IP Security Agreements with all attendant liens, rights, title, assignments and interests (including security interests) pertaining to or arising from the Security Documents, including in and to the Collateral scheduled on the IP Security Agreements. Nothing herein shall be deemed to terminate, interrupt, or impair the continuity of the security interest in and to the Collateral granted to the Resigning Agent under the Credit Documents, including the IP Security Agreements and the Collateral identified on Schedule A attached hereto, which security interest is now succeeded by and transferred to the Successor Agent.

3. Incorporation. All terms set forth in the Resignation, Waiver, Consent and Appointment Agreement are hereby incorporated herein by reference with the same force and effect as though fully set forth herein. To the extent that the terms set forth herein are inconsistent with the terms of the Agency Resignation and Assignment Agreement, the terms set forth in Agency Resignation and Assignment Agreement shall apply.


