2. Recordation. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Trademark Assignment upon request by the Assignee. Following the date hereof and for a period of 12 months thereafter, upon the Assignee's reasonable request, and at the Assignee's sole cost and expense, each of the Assignors shall take such steps and actions, and provide such cooperation and assistance to the Assignee, its Affiliates and its and their successors, assigns and representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned Rights to the Assignee, or any assignee or successor thereto.
3. Further Actions. Assignor agrees to execute and deliver at the request of Assignee, any papers, instruments and assignments reasonably necessary to vest in Assignee all of Assignor's right, title and interest in and to the Marks and the applications and registrations therefor and/or to provide evidence to support such assignment in the event such evidence is reasonably necessary and to the extent such evidence is in the possession or control of Assignor.
4. Binding Effect. This Trademark Assignment and all of the provisions hereof shall be binding upon and inure to the benefit of each of the parties hereto and their respective successors and permitted assigns.
5. Counterparts.
