**Release of Second Lien Trademark Security Agreement**

This Release of Second Lien Trademark Security Agreement, dated as of January 20, 2023 (the “Release”), is made by Newstone Capital Partners, LLC, as collateral agent (in such capacity, “Collateral Agent”) in favor of DONORBASE, INC., a New York corporation, and LAKE GROUP MEDIA INC., a New York corporation (both a “Grantor” and collectively the “Grantors”).

WHEREAS, by (i) that certain Second Lien Collateral Agreement, dated as of April 3, 2017, by and among Infogroup Parent Holdings, Inc., a Delaware corporation, the other grantors from time to time party thereto (including the Grantors) and Collateral Agent (as amended, restated, or modified from time to time, the “Security Agreement”) and (ii) that certain related Second Lien Trademark Security Agreement, dated as of June 6, 2022, in favor of Collateral Agent (as amended, restated, or modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable), the Grantors granted to Collateral Agent, for the benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantors desire Collateral Agent to release, discharge, terminate and cancel its lien on and security interest in the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule I hereto;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, its successors and assigns, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in, to and under the Trademark Collateral, including, without limitation, the Security Interest and any and all goodwill relating to the Trademark Collateral, and assigns, transfers and conveys to the Grantors any and all of its rights, title and interests in, to, and under the Trademark Collateral.

Collateral Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


