RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated February 16, 2023 by BANK OF MONTREAL (“*BMO*”), a Canadian chartered bank, acting through its Chicago Branch, with its mailing address at 115 South LaSalle Street, Chicago, Illinois 60603, acting as administrative agent hereunder for the Secured Creditors as defined in the Trademark Collateral Agreement referred to below (BMO acting as such administrative agent being hereinafter referred to as the “*Agent*”), in favor of WEST COAST UNIVERSITY, INC. (f/k/a Acton Educational Services, Inc.), a California corporation (“*Debtor*”) with its principal place of business and mailing address at 151 Innovation Drive, Irvine, California 92617.

WITNESSETH:

WHEREAS, Debtor and Agent were parties to that certain Security Agreement dated as of November 8, 2019 (“*Security Agreement*”; capitalized terms used herein, but not otherwise defined herein, shall have the meanings assigned to them in the Security Agreement) and that certain Trademark Collateral Agreement dated November 8, 2019 which was recorded in the United States Patent and Trademark Office on November 8, 2019 at Reel 6792, Frame 0702 (the “*Trademark Collateral Agreement*”), pursuant to each of which Debtor granted to Agent for the benefit of the Secured Creditors a continuing security interest in the Trademark Collateral (as defined below), including those listed on Schedule A; and

WHEREAS, Debtor has requested that Agent release its security interests in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Agent, on behalf of the Secured Creditors, hereby releases its continuing security interest in, without any representation, warranty, recourse or undertaking by Agent, the following (collectively, the “*Trademark Collateral*”):

(i) each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.

Agent, on behalf of the Secured Creditors, hereby authorizes the recordation of this Release of Security Interest in Trademarks with the United States Patent and Trademark Office at Debtor’s expense.
