TRADEMARK ASSIGNMENT

WHEREAS, MACMARK CORPORATION, a Delaware Corporation, with a principal place of business at 1700 West Higgins Road, Suite 500, Des Plaines, Illinois 60018 (“Assignor”), has adopted, owns, and is using the MACGREGOR trademark (the “Mark”) in connection with athletic equipment and athletic apparel; and

WHEREAS, Assignor owns United States Registration No. 1705112 for the Mark covering “athletic apparel; namely, baseball caps, sneakers, athletic shoes, warm-up and jogging suits, running shorts, running shoes, T-shirts, sweat and athletic socks, and parts of team uniforms; namely, team jerseys, uniform tops, uniform pants and uniform socks” in Class 25 (the “’112 Registration”);

WHEREAS, on February 1, 2023, Assignor filed an application to renew the ‘112 Registration in which Assignor amended the goods recited in the Registration to read “athletic apparel; namely, sneakers, athletic shoes, T-shirts;”


WHEREAS, Assignor has recently applied to register the Mark on the Principal Register of the United States Patent and Trademark Office in connection with “Golf shirts; golf hats” in Class 25 (Serial No. 97670066) (the “’066 Application”); and

WHEREAS, RAM GOLF LTD., a Hong Kong limited company, with a principal place of business at Suite 14A, Capri Building, 130 Austin Road, Kowloon, Hong Kong (“Assignee”), desires to acquire Assignor’s rights in and to the Mark as it relates to t-shirts, golf shirts, and golf hats including the ‘066 Application and the portion of the ‘112 Registration covering “t-shirts.”

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee all right, title and interest in and to (1) the Mark as it relates to t-shirts, golf shirts, and golf hats (collectively,

the "Assigned Goods"); (2) the '066 Application; and (3) the portion of the '112 Registration covering "t-shirts," together with the goodwill of the business symbolized by the Mark as it relates to the Assigned Goods as well as that portion of Assignor's business in connection with which it uses and/or has a *bona fide* intent to use the Mark on or in connection with the Assigned Goods.
