PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “*Partial Release*”) is granted as of February 17, 2023 by **SK FINANCIAL SERVICES, LLC**, as administrative agent (the “*Grantee*”), in favor of **PARKER LIFESTYLE, LLC**, a Delaware limited liability company (the “*Grantor*”);

WHEREAS, the Grantor, among others, has executed and delivered: (i) that certain Guarantee and Collateral Agreement, dated as of December 11, 2020 (as amended from time to time and in effect on the date hereof, the “*Security Agreement*”), in favor of the Grantee, (ii) that certain Grant of Security Interest in United States Trademarks, dated as of December 11, 2020 (the “*2020 Trademark Security Agreement*”), which was recorded with the United States Patent and Trademark Office (the “*PTO*”) on December 16, 2020, at Reel 7137 and Frame 0180 and (iii) that certain Grant of Security Interest in United States Trademarks, dated as of September 23, 2022 (the “*2022 Trademark Security Agreement*”) and, together with the 2020 Trademark Security Agreement, each a “*Trademark Security Agreement*” and, collectively, the “*Trademark Security Agreements*”), which was recorded with the PTO on September 23, 2022 at Reel 7854 and Frame 0742, pursuant to which the Grantor has granted a security interest in and to all of its rights, title and interest in and to all Marks (as defined in each Trademark Security Agreement); and

WHEREAS, the Grantor has requested that the Grantee release such security interest granted pursuant to the Trademark Security Agreements, but solely with respect to the trademarks, trademark registrations, and trademark applications listed on Schedule A (the “*Specified Marks*”), together with (a) all applications and registrations with respect to the Specified Marks, (b) all proceeds and products of the Specified Marks, (c) the goodwill of the businesses with which the Specified Marks are associated, and (d) all causes of action arising prior to or after the date hereof for infringement of any of the Specified Marks or unfair competition regarding the same (the Specified Marks, together with clauses (a)-(d), the “*Released Collateral*”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee does hereby (i) release and discharge, without any representation or warranty, any and all liens and security interests it may have in and to the Released Collateral, and (ii) terminates the Trademark Security Agreements solely with respect to the Released Collateral.

The Grantee hereby authorizes and requests that the PTO note and record this Partial Release.

Except for the release of the Specified Marks specifically identified on Schedule A attached hereto and other Released Collateral, all terms and provisions of the Trademark Security Agreements shall remain in full force and effect. Nothing contained herein shall in any way impair the validity or enforceability of the Trademark Security Agreements, as modified hereby, or alter, waive, annul, vary, affect, or impair any provisions, conditions, or covenants contained therein or any rights, powers, or remedies granted therein. **Any lien and/or security interest granted in any Mark pursuant to the Trademark Security Agreements or the Security Agreement shall remain unchanged and in full force and effect except as specifically released hereby and shall continue to secure the payment and performance of all of the Secured Obligations (as defined in the Security Agreement).**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
