TRADEMARK ASSIGNMENT

This Trademark Assignment is effective as of May 24, 2022 (the “Effective Date”), and is made by and between AT&T Intellectual Property II, L.P., a Nevada limited partnership having an address at 645 E. Plumb Lane, Reno, Nevada 89502 (the “Assignor”), and Xandr Inc., a Delaware corporation having an address at 28 W. 23rd Street, 4th Floor, New York, NY 10010 (the “Assignee”).

W I T N E S S E T H:

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademark applications and trademark registrations identified in the attached Schedule A (collectively, the “Trademarks”);

WHEREAS, pursuant to that certain Stock Purchase Agreement by and between AT&T Inc. and Microsoft Corporation dated as of December 21, 2021 (the “Purchase Agreement”), Assignor has agreed to contribute, transfer and assign the Trademarks to Assignee; and

WHEREAS, Assignor and Assignee desire that the assignment of said rights in the Transferred Registered IP be made of record in the respective intellectual property offices (where applicable), including all foreign trademark and patent offices and/or any other appropriate governmental or administrative offices.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment of Trademarks. Assignor hereby assigns, grants, transfers, conveys, and delivers exclusively to Assignee and Assignee hereby acquires from Assignor ownership and any and all of Assignor’s right, title, and interest in and to the Trademarks, the goodwill symbolized thereby, any applications and registrations related thereto and all associated common law rights, and the right to claim any applicable priority rights arising from the Trademarks (the “Assignment”). All rights to the Trademarks, including, without limitation, the right to sue for any damages and other remedies in respect of any infringement of the Trademarks, which may have occurred prior to the date of this Trademarks Assignment, shall be the sole property of Assignee and inure to the benefit of Assignee.

2. Controlling Agreement. This Agreement is executed pursuant to, in furtherance of and is subject to, the terms and conditions of the Purchase Agreement. This Agreement shall not replace, substitute, expand or extinguish any obligation or provision of the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall control.

3. Further Assurances. Assignor will, upon reasonable request, without further consideration, execute such additional writings prepared and filed at the expense of Assignee necessary for the prosecution, maintenance and renewal of the Trademarks before the trademark

office or any equivalent authorities in foreign countries, as may be reasonably necessary up and until the Assignment is made effective, at which time all such aforementioned actions and/or responsibilities on behalf of Assignor outlined in this section will cease. Assignor hereby agrees without any additional consideration therefor to sign all documents and make all filings, assignments and declarations reasonably required to assign and transfer the Trademarks to Assignee, including such additional filings, instruments and notices as may be required in each applicable foreign jurisdiction to effect a valid assignment of such Trademarks in such jurisdiction.

4. Successors and Assigns. The terms and provisions of this Trademark Assignment and the respective rights and obligations of the parties hereunder shall be binding upon the parties and inure to the benefit of their respective successors and assigns.

5. Representations and Warranties. Each Party hereby represents and warrants to the other Party that: (a) it has the power and authority to enter into this Agreement and to fully perform its obligations hereunder; (b) this Agreement has been duly authorized, executed and delivered by it and (c) this Agreement is a valid and binding agreement enforceable against it in accordance with the terms hereof except as enforceability may be limited by bankruptcy laws, other similar laws affecting creditors' rights and general principles of equity affecting the availability of specific performance and other equitable remedies

6. Recordings. An executed copy of this Trademark Assignment may be filed with the appropriate national trademark office by Assignee or Assignor at any time.

7. Execution. This Trademark Assignment may be executed by facsimile or as an attachment to an email transmission and in counterparts, each of which shall be deemed an original and all of which together will constitute one instrument.
